Requested Variance #1 – We will be requesting a variance for the landscape screening requirements at the overhead rolling doors located at the North Elevation at the Shooting Range. Overhead door is required for ammunition drop-off for the City of McKinney. The rolling doors at the shooting range cannot provide screening due to the requirements of the interlocal agreement between the City of McKinney and Collin College. This agreement requires the north road on the site to straddle the site property line to be half on our proposed site and half on the site to the North currently owned by the City of McKinney. This precludes us from having a landscape screen buffer area for our rolling door as the rolling door is for vehicular access off of this driveway.

Requested Variance #2 – We will be requesting a variance for the landscape screening requirements at the overhead rolling doors located at the North Elevation at the Simunitions Area. Overhead door is required for SWAT team training by the City of McKinney and other outside agencies. The rolling doors at the Simunitions area cannot provide screening due to the requirements of the interlocal agreement between the City of McKinney and Collin College. This agreement requires the north road on the site to straddle the site property line to be half on our proposed site and half on the site to the North currently owned by the City of McKinney. This precludes us from having a landscape screen buffer area for our rolling door as the rolling door is for vehicular access off of this driveway. It is imperative for SWAT team training that they be able to drive an armored car directly into this training area and is required to be off of an access road.
