13-327 Mayor Loughmiller called for Consideration/Discussion/Action on an Ordinance Amending the Budget to Fund Air Traffic Control Services at Collin County Regional Airport. City Manager Gray stated at that the last Council meeting the Council authorized the funding of air traffic control services at the Collin County Regional Airport. This is the budget amendment for the allocation of those dollars. Mr. Gray stated that the City learned last week that the Texas Department of Transportation (TxDOT) is planning on providing a reimbursement to the cities or entities that would be out of the money to keep the air traffic control towers fully functional and operational in a manner that they have run historically. The budget amendment is necessary because the TxDOT funding would be a reimbursement. The City will expend the funds upfront and TxDOT will reimburse the City 90% of the cost. Mr. Gray stated that these funds would come out of the Airport reserve funds and when the reimbursement is received, the funds would be put back in the Airport reserve funds. Council unanimously approved the motion by Council member Kever, seconded by Council member Harris, to approve an Ordinance amending the budget to fund Air Traffic Control Services at Collin County Regional Airport with the addition of the following: Should Texas Department of Transportation Aviation Division grant the City of McKinney a ninety percent reimbursement of the contract for air traffic control services, funds received from the reimbursement will be deposited back into the Airport Fund to be used for future airport related expenses. Grants Coordinator Janay Tieken and McKinney Arts Commission Chair Linda Spina were available to answer questions from Council. Ms. Spina stated that the only change to the Plan was the

addition of the Council requested language that up to ten percent of the City allocated grant funds be used to support public art projects and initiatives. When this or any other source of City funding is used to support public art, the Arts Commission will contribute at least a 50-50 match from external fundraising. Council unanimously approved the motion by Council member Harris, seconded by Council member Council member Ricchi, to approve a Resolution adopting Public Art Master Plan and Administrative Guidelines. Mayor Pro-Tem Ussery stepped down on the next agenda item.

Director of Planning Michael Quint stated that the applicant is proposing to construct a 222 feet tall elevated water storage tank on the north side of F.M. 543 (Weston Road) and approximately 3,000 feet east of C.R. 229 which is part of the Trinity Falls MUD agreement. The applicant is proposing to enclose the property with a wrought iron screen device with masonry columns on 20 foot centers with an evergreen living screen. The applicant is requesting a meritorious exception to allow for chain linked fencing for approximately 250 feet of the western boundary line. Staff is in support of the site plan with the exception of the request for the meritorious exception. Applicant, Mr. Russell Kennedy, 750 Genesis Court, Suite 200, Frisco, stated Grayson County Election has a substation adjacent to the property on the west side that has a six foot chain link fence with barbed wire along the property. Mayor Loughmiller called for public comment and there was none. Council approved the motion by Council member Kever, seconded by Council member Day, to approve a Site Plan for a City elevated water storage tank (Trinity Falls), being fewer than 3 acres, located approximately 3,000 feet east of C.R. 229 and on the north side of F.M. 543 (Weston Road), with the following The applicant satisfy the conditions as shown on the conditions: Standard Conditions for Site Plan Approval Checklist and the applicant receive approval of a meritorious exception requiring an approximately 62' long section of wrought iron fencing with masonry columns 20' on center with living plant screen along the western property line from the F.M. 543 (Weston Road) right-of-way, northward, in conjunction with a maximum of an approximately 256' long section of chain linked fencing along the western side of the subject property with a vote of 5-0-1, with Mayor Pro-Tem Ussery abstaining.

Mayor Loughmiller called for Council and Manager Comments.

Council member Harris stated that he remembered when he was campaigning to run for City Council he heard comments on how to difficult it was to work with the City of McKinney. Mr. Harris applauded City staff including Development Services for turning that around. Mr. Harris stated that efficiencies can be gained with improved technology. Mr. Harris complimented the Parks Department for the successful Dog Park and the popularity among the residents of McKinney. Mr. Harris stated that when a City becomes an airport sponsor it has a responsibility including the safety operations of the air side of the facility. In addition, there are tremendous benefits to the community. Aircraft based at the airport provides a substantial tax base. It was once said that a private jet pays in taxes as a three story office building. Aircraft do not require utility infrastructure or have children attending public school. Many types of businesses locate close to airports and bring with them high paying jobs. Our airport is the entry way to our community for anyone using general aviation. When the Federal Government indicated it would close airport control towers due to financial issues, our Mayor took the decisive action to direct the City of McKinney to find some other method of funding to continue the control tower operation. A few weeks later, TxDOT Aviation Department looked at the issue and agreed with our Mayor that the control tower operations were not only vital to our travelling public but also vital to the State's economy. Mr. Harris stated that he commended the Mayor's foresight to continue the safe operations for all of the citizens of McKinney.

Mayor Pro- Tem Ussery stated that he and Council member Day had the opportunity to attend a Town Hall meeting. He stated that he appreciated the opportunity to meet before the citizens. Mr. Ussery thanked staff for what they do every day. The Dog Park is a great example of staff's commitment to the community. Mr. Ussery thanked Michael Quint for working through the zoning ordinance amendments. He expressed his attentiveness to these issues. Mr. Ussery said that he enjoyed serving ice cream to the public on Saturday night

Council member Kever stated that Council spends a lot of time discussing economic development, ways to bring new businesses to our community, what that means to our tax base, and what that means to our ability to provide services and quality of lifestyle to the community. Ms. Kever stated that the Council spends a fair bit of time talking about how to retain and grow businesses that are already here. The City currently has only one publicly traded company headquartered in McKinney (Encore Wire). Independent Bank that is headquartered in McKinney will be going public tomorrow with an initial public offering. Ms. Kever showed a video clip of a news story discussing the Independent Bank public offering that referenced the City of McKinney.

Council member Day did not have any comments.

Council member Ricchi mentioned that Mayor Loughmiller was in the current Forbes Magazine. Mr. Ricchi stated that several of the Mayor and Council will be attending and participating in the opening ceremonies for the McKinney Independent School District Special Olympics. Mr. Ricchi encouraged everyone to get out there in support and get involved in the fantastic program that MISD does for all our special Olympians.

Mayor Loughmiller stated that there are a lot of events happening this month. This Thursday night will be the MISD Teacher of the Year celebration. We have been fortunate enough in McKinney to not only have recognized teachers but one of our elementary teachers who was named as Teacher of the Year. We have the Special Olympics on Friday that is a wonderful event with terrific kids participating. On Saturday, there will be a Trails 5K that is part of the Mayor's Health Initiative to encourage people to get out and participate in healthy activities. One of the fourth grade classes at Vega Elementary School decided to give up their chairs that they
