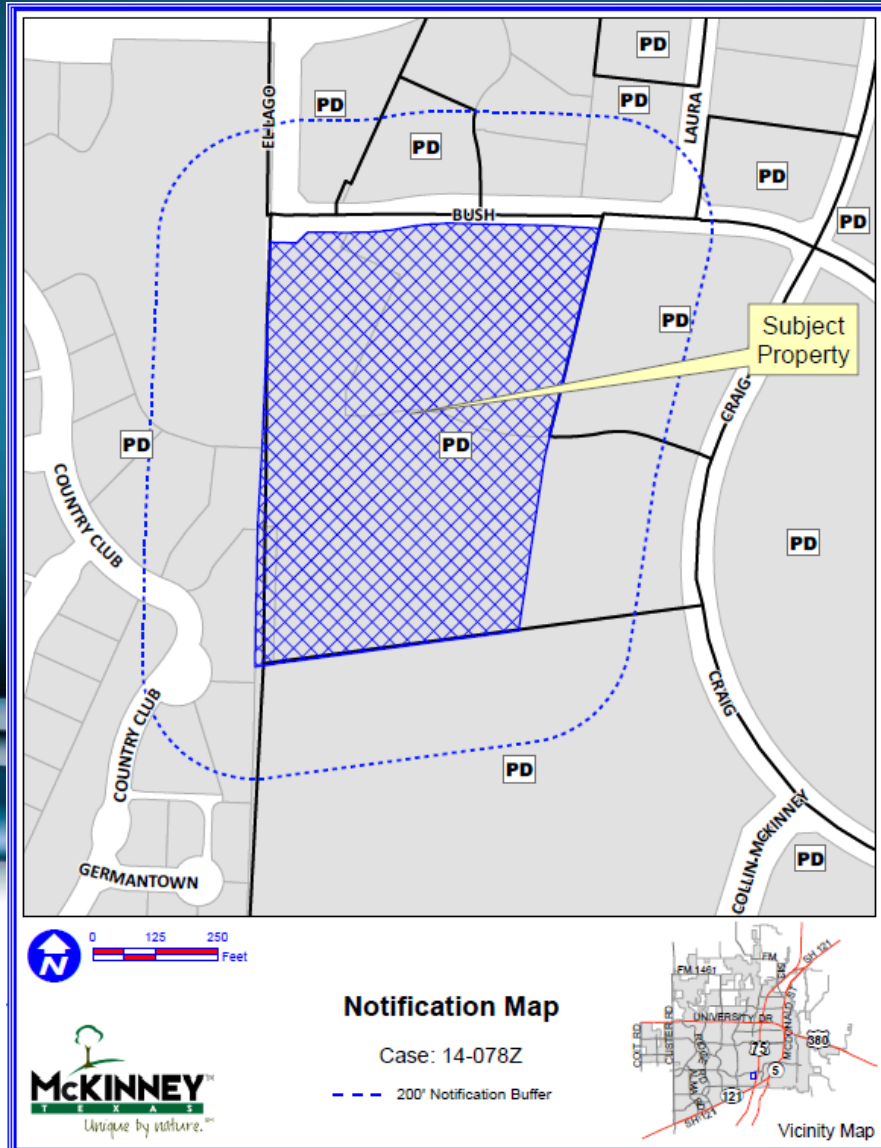

# Location Map

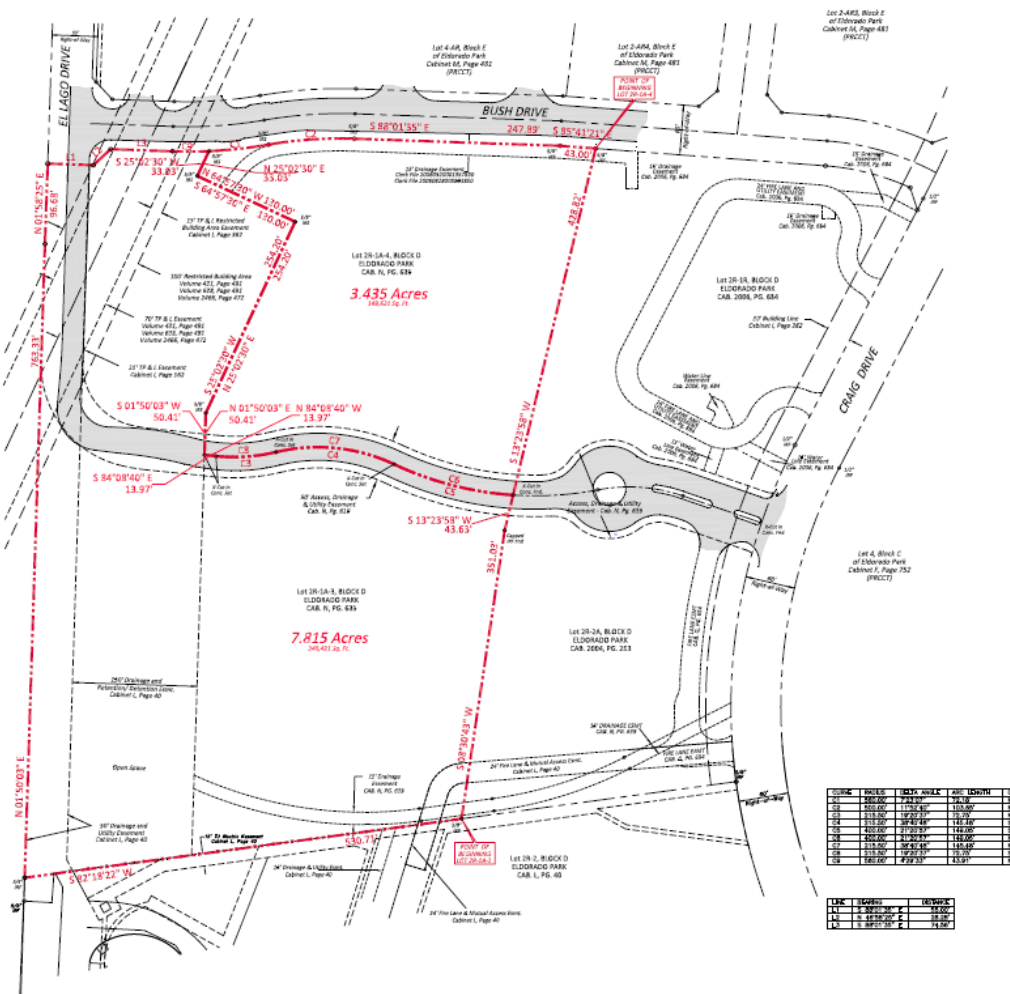
