

ORDINANCE NO. 2021-09-___

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AMENDING THE CODE OF ORDINANCES OF THE CITY OF MCKINNEY, TEXAS, RELATING TO FEES, BY AMENDING THE CODE OF ORDINANCES SECTION 30-85, AND BY AMENDING APPENDIX A SCHEDULE OF FEES, IN PART, BY AMENDING SECTIONS 30-71, 30-85, 30-86, 30-175, 30-205, 110-35, 110-37, 110-42, 110-44, 110-45, 110-95, 110-139, 110-142, 110-230, 142-133, AND 146-193; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A REPEALER CLAUSE; PROVIDING FOR PUBLICATION OF THE CAPTION OF THIS ORDINANCE; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF

WHEREAS, the City Council of the City of McKinney, Texas, finds, determines, and declares that certain fees are necessary to provide for efficient government services; and

WHEREAS, the City Council of the City of McKinney, Texas, finds and determines that the current fees are insufficient to cover the costs of the respective services; and

WHEREAS, the City Council of the City of McKinney, Texas desires to adopt fees necessary for the City to provide good and efficient government for the benefit of the citizens of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS:

Section 1. That the findings set forth above are incorporated into the body of this Ordinance as if fully set forth herein.

Section 2. That Appendix A, entitled "Schedule of Fees", of the Code of Ordinances, City of McKinney, Texas, Section 30-71, is hereby amended to read as follows:

Appendix A, Section 30-71. U.S. customs fee.

Customs fee~~200.00~~ 250.00/500.00

Customs Agents overtime fee, per Customs Agent for international flights arriving before or after normal business hours at McKinney National Airport350.00

Note: Normal business hours are defined as 8:00 a.m. to 5:00 p.m., Monday through Friday, excluding holidays. The amount of time and number of agents to process a flight is solely determined by U.S. Customs. Fees could be higher based on the resources assigned by U.S. Customs.

Section 3. That the Code of Ordinances, City of McKinney, Texas, Section 30-85, is hereby amended to read as follows:

Sec. 30-85. – Fees for airport access cards, ~~and keys,~~ replacement, and returned payments.

(a) Each person requesting access onto the airport through its security perimeter gates shall apply and be approved by the airport director or his designee as a condition to the issuance of an airport access card. A fee shall be charged to each applicant for initial issuance, replacement and bi-annual renewal in an amount as specified in Appendix A—Schedule of Fees of the Code of Ordinances which may be amended from time to time by ordinance. Each person utilizing offices at the airport shall apply for and be approved by the airport director or his designee as a condition of the issuance of office keys. A fee shall be charged to each applicant for

replacement in an amount as specified in Appendix A—Schedule of Fees of the Code of Ordinances which may be amended from time by ordinance.

(b) The application fee shall be made with credit card, cash or check made payable to the "City of McKinney, Texas." A fee will be charged for returned ~~checks~~payments in an amount specified in Appendix A—Schedule of Fees of the Code of Ordinances which may be amended from time to time by ordinance.

Section 4. That Appendix A, entitled "Schedule of Fees", of the Code of Ordinances, City of McKinney, Texas, Section 30-85, is hereby amended to read as follows:

Appendix A, Section 30-85. Fees for airport access cards, keys, and returned ~~payments~~checks.

(a) A fee for the administrative and logistics cost of issuing airport security access cards to airport facilities.

Section 19. That if any section, subsection, paragraph, sentence, phrase or clause of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall remain in full force and effect, and to this end, the provisions of this Ordinance are declared to be severable.

Section 20. That this Ordinance shall be cumulative of all other ordinances of the City and shall not repeal any of the provisions of said ordinances except in those instances where provisions of those ordinances are in direct conflict with the provisions of this Ordinance and such ordinances shall remain intact and are hereby ratified, verified and affirmed.

Section 21. The caption of this Ordinance shall be published one time in a newspaper having general circulation in the City of McKinney.

Section 22. This Ordinance shall become effective October 1, 2021.
