CITY COUNCIL REGULAR MEETING

DECEMBER 20, 2022

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, December 20, 2022, at 6:00 p.m.

The meeting was broadcast live on cable television Spectrum Channel 16 and AT&T U-Verse Channel 99; and online at https://mckinneytx.new.swagit.com/views/130. The video recording is available to members of the public through the City of McKinney meeting archive.

Mayor Pro Tem Rainey Rogers called the meeting to order at 6:00 p.m. upon determining a quorum consisting of himself and the following City Council members were present: Geré Feltus, Rick Franklin, Charlie Philips, and Patrick Cloutier.

Mayor George Fuller, and Council Member Justin Beller were absent. Mayor Pro
Tem Rogers extended well wishes to Mayor Fuller, noting that Mayor Fuller was absent
due to illness.
