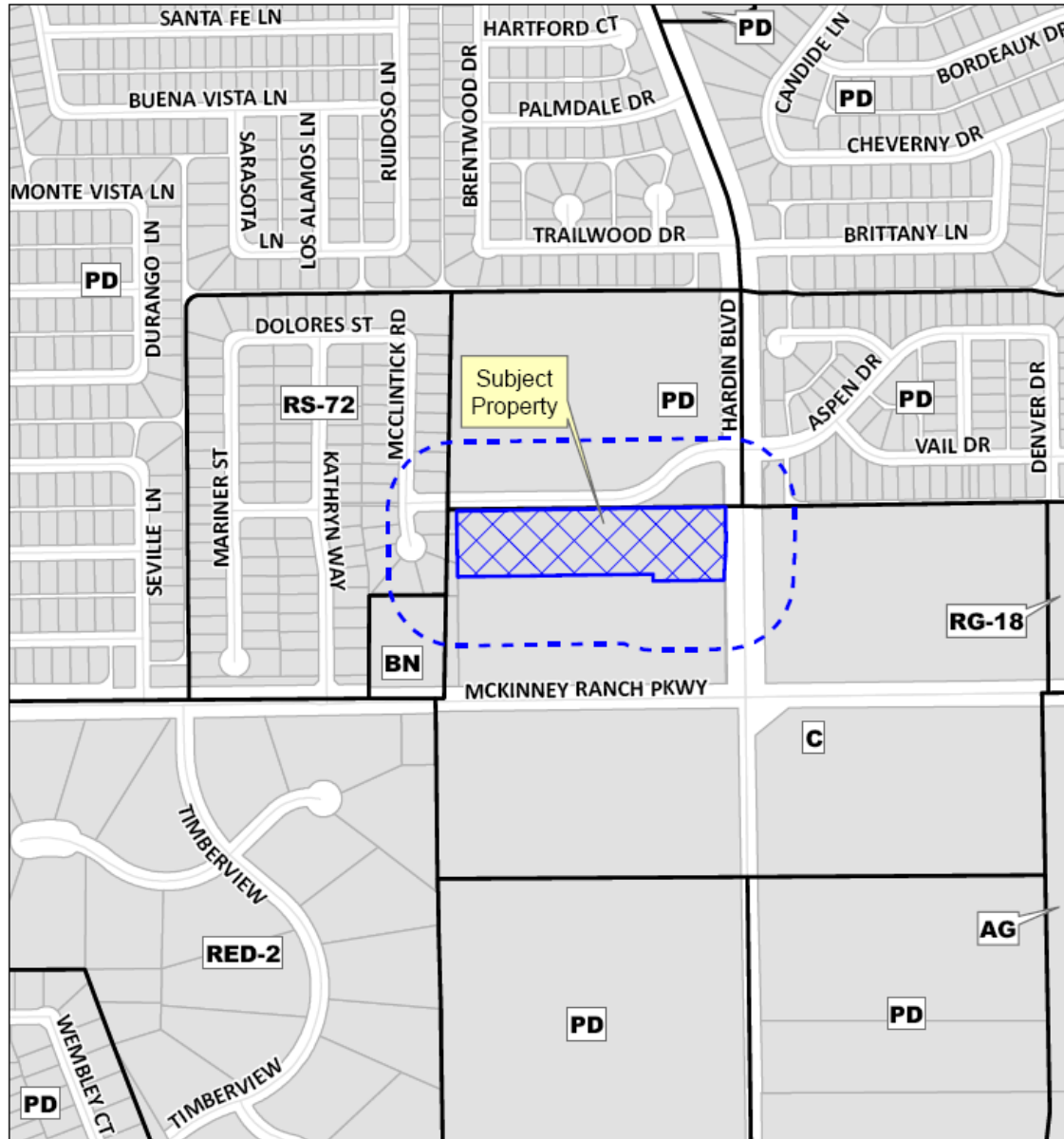

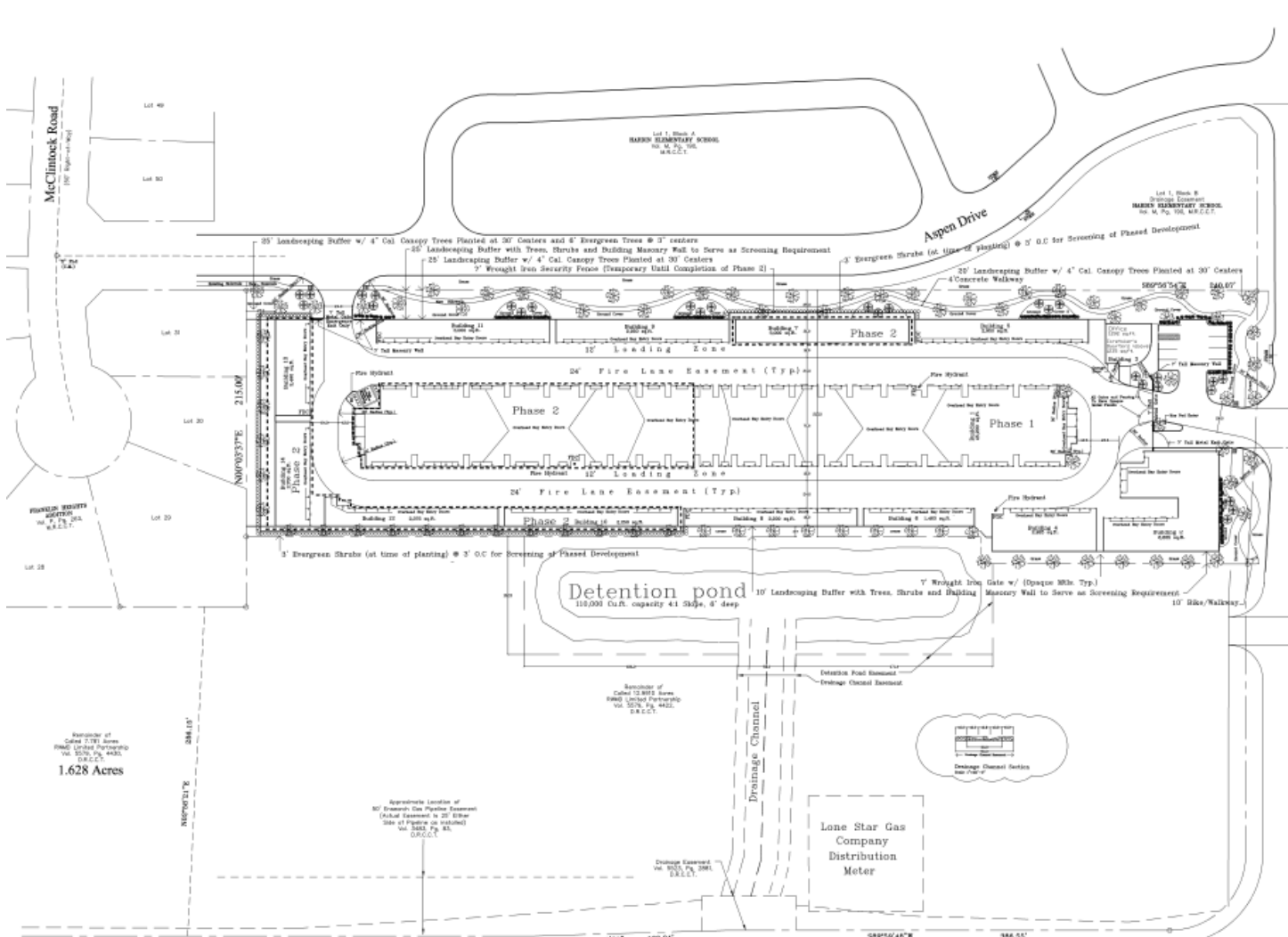
Location Map
