**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, APPROVING THE COMMUNITY DEVELOPMENT BLOCK GRANT FY 2020 ANNUAL ACTION PLAN UNDER THE CONSOLIDATED PLAN, AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, the City Council authorizes the City Manager to make application for Community Development Block Grant Funds (CDBG); and

**WHEREAS**, the U.S. Department of Housing and Urban Development will review and accept the Annual Action Plan providing CDBG funds for the 2020-2021 fiscal year to begin October 1, 2020; and

**WHEREAS**, the Community Grants Advisory Commission held three public meetings and prepared recommendations for Council acceptance of the Annual Action Plan under the use of Community Development Block Grant Funds, including the 2020 CDBG allocation and CDBG-CV funding to prevent, prepare and respond to the spread of Coronavirus disease (COVID-19); and

**WHEREAS**, activities under the Annual Action Plan includes agency funding recommendations, city programs and grant administration under housing and community development; and

**WHEREAS**, the U.S. Department of Housing and Urban Development will give final approval of the 2020 Annual Action Plan.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

Section 1. The Action Plan is hereby adopted with funding allocations as follows:


