

**RESOLUTION NO. 2012-07-\_\_\_\_ (R)**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY,  
TEXAS, AUTHORIZING AMENDING THE 2012 – 2016 CAPITAL  
IMPROVEMENTS PROGRAM FOR THE CIPP LINER FOR 27-INCH  
SANITARY SEWER TRUNK MAIN PROJECT**

**WHEREAS**, the 2012-2016 Capital Improvements Program is a component of the City of McKinney Annual Budget: Fiscal year 2011-2012; and

**WHEREAS**, the City Council wishes to amend the 2012-2016 Capital Improvement Program to modify the funding for several projects.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

- Section 1. The FY 2011-2012 budget for the Aerial Wastewater Crossings Improvements WW0221, is hereby changed to \$365,000, as follows: Revenue Bonds \$75,000, Fund Balance \$290,000 (reduced from \$500,000).
- Section 2. The FY 2011-2012 budget for the Inflow/Infiltration Projects FY 2010-2011 WW5024, is hereby changed to \$380,000, as follows: Fund Balance \$380,000 (reduced from \$430,000).
- Section 3. The FY 2011-2012 budget for the Dudperkins St. Sewer WW6025, is hereby changed to \$1,310,000, as follows: Fund Balance \$146,000 (reduced from \$286,000), and Revenue Bonds \$1,164,000.
- Section 4. The FY 2011-2012 budget for the US 75 Wastewater Main Relocation – South Section WW9119, is hereby changed to \$3,800,000, as follows: Grants-TxDOT \$900,000, Fund Balance \$1,296,428 (reduced from \$1,396,428), and Revenue Bonds \$1,603,572.
- Section 5. The FY 2011-2012 budget for the CIPP Liner for the 27-Inch Sanitary Sewer Trunk Main WW3234, has been created with a budget of \$500,000 from the above identified funding sources.
- Section 6. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
