A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, APPROVING THE COMMUNITY DEVELOPMENT BLOCK GRANT 2016-2017 ACTION PLAN, AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City Council authorizes the City Manager to make application for Community Development Block Grant Funds (CDBG); and

WHEREAS, the U.S. Department of Housing and Urban Development will review and accept the Annual Action Plan providing CDBG funds for the 2016-2017 fiscal year to begin October 1, 2016; and

WHEREAS, the Community Grants Advisory Commission held three public meetings and prepared recommendations for Council acceptance of the Annual Action Plan under the use of Community Development Block Grant Funds, including allocation and carryover funds; and

WHEREAS, the U.S. Department of Housing and Urban Development will give final approval of the 2016-2017 Annual Action Plan.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. The 2016-2017 Action Plan is hereby adopted with funding allocations as follows:
