A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, AUTHORIZING THE INTERIM CITY MANAGER TO EXECUTE A CONTRACT IN THE AMOUNT OF \$1,957,716 WITH NORTH ROCK CONSTRUCTION, LLC OF DENTON, TEXAS FOR THE CONSTRUCTION OF THE SONNTAG NEIGHBORHOOD/SCHOOL PARK PROJECT AND AUTHORIZING ALL NECESSARY CHANGE ORDERS UNDER SAID CONTRACT UP TO AN AGGREGATE CONTRACT AMOUNT, INCLUSIVE OF ANY CHANGE ORDERS, NOT TO EXCEED \$2,059,176

- **WHEREAS**, the City Council of the City of McKinney, Texas, has determined a need for a neighborhood school park. The park will include two play structures, splash pad, pavilion, parking, lighting and a hike and bike trail loop around the perimeter of the park site; and
- WHEREAS, the City Council approved the budget on September 16, 2014; and
- WHEREAS, the project has been bid in a manner consistent with State Law; and
- **WHEREAS,** a bid evaluation resulted in the selection of North Rock Construction, LLC as the lowest, responsive bidder; and
- **WHEREAS,** the City has prepared a contract with North Rock Construction, LLC to construct the Sonntag Neighborhood/School Park Project (PK9140).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. The City Council of the City of McKinney, Texas hereby accepts the bid in the amount of \$1,957,716 to construct the Sonntag Neighborhood/School Park project.
- Section 2. The Interim City Manager is hereby authorized to execute a contract in the amount of \$1,957,716 with North Rock Construction, LLC for the construction of the Sonntag Neighborhood/School Park project and authorizing all necessary change orders under said contract up to an aggregate contract amount, inclusive of any change orders, not to exceed \$2,059,176.
- Section 3. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
