**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
McKINNEY, TEXAS, APPROVING THE 2017-2018 COMMUNITY
SUPPORT GRANT FUNDING ALLOCATIONS, AND PROVIDING
AN EFFECTIVE DATE**

WHEREAS, the City Council established the Community Support Grant to support direct funding assistance for qualifying non-profit agencies serving the City of McKinney and its residents; and,

WHEREAS, the Community Grants Advisory Commission for the City of McKinney received grant applications from qualifying non-profit agencies totaling \$153,433; and,

WHEREAS, the 2017-2018 Community Support Grant budget includes \$119,700 in funding to qualifying non-profit agencies; and,

WHEREAS, the Community Grants Advisory Commission held two public hearings and prepared recommendations for Council acceptance of the use of Community Support Grant funds; and,

WHEREAS, the City Council of the City of McKinney, Texas, finds and determines the funding for the following qualifying non-profit agencies accomplishes a public purpose and municipal purpose for the City of McKinney.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF
McKINNEY, TEXAS, THAT:**

Section 1. The 2017-2018 Community Support Grant is hereby approved with funding allocations as follows:
