Facilities Construction Manager Patricia Jackson stated that tonight the Council and McKinney Community Development Corporation Board will be receiving an update on the design and construction process for the McKinney Aquatics and Fitness Center project. Ms. Jackson stated that the project is in the development stage after having completed the schematic design. The design team includes Dwayne Brinkley and Steven Springs from Brinkley Sargent, Mark Bodien with Moody Nolan representing the design side, Wesley Weaver with Manhattan Construction, and Ken Poppy who is the Chief Estimator. Mr. Brinkley stated that the project is on schedule to open in the summer of 2016. The design team presented various schematic drawings of the Gabe Nesbitt Park layout, the building positioning on the park site, and the inside schematics of the proposed project.
