

BASIS OF BEARINGS:

The basis of bearings, horizontal and vertical position are derived from Texas WDS RTK Network, Texas State Plane Coordinates System, Nad83, North Central Zone, Nad 83 (CORS96) Epoch 2002.0, Vertical position are referenced to NAVD88 using (GEIOD03).

NOTES:

All proposed lots situated in whole or in part within the city's corporate limits comply with the minimum size requirements of the governing zoning district and requirements of the subdivision ordinance.

Coordinates shown are on the Texas State Plane Coordinate System, North Central Zone 4202, North America Datum of 1983 on grid coordinate values, no scale and no projection.

at the southeast corner of said Lot 44, said iron rod being in the north line of Block B, Standifer Place Addition No. 2 as recorded in Volume P. Page 915,

THÉNCE N 89°07'50" W following the north line of said Block B a distance of 100.00'a capped (stamped "4613") 1/2" iron rod found for corner at the southwest corner of said Lot 44;

THENCE N 00°02'47" E a distance of 207.50'a capped 1/2" iron rod found for corner at the northwest corner of said Lot 44, said iron rod being in the south Right Of Way line of Anthony Street (40' ROW); THENCE S 89°07'50" E following the south Right Of Way line of Anthony Street a distance of 100.00'a capped 1/2" iron rod found for corner at the

northeast corner of said Lot 44: THENCE S 00°02'47" W a distance of 207.50' to the POINT OF BEGINNING and containing 20748 Square Feet or 0.476 Acres of land.

That, North Collin County Habitat for Humanity, Inc. acting herein, are the owners and does hereby adopt this Minor Replat designating the herein above described property as HABITAT NO. 1 ADDITION, Lots 1 and 2, Block A, Being a Replat of Lot 44, Block 12, W.J.S. Russell's Third Addition, an Addition to the City of McKinney, Collin County, Texas, according to the Map or Plat thereof recorded in Volume 91, Page 238, Map Records, Collin County, Texas, and part of the 15' Alley that was Abandon by City Ordinance No. 2003—03—027 and does hereby dedicate to the public use forever, the streets, alleys, and public use areas shown thereon, the easements as shown, for the mutual use and accommodation of the City of McKinney and all public utilities desiring to use or using same. All and any public utility and the City of McKinney shall have the right to remove and keep removed all or parts of any buildings, fences, shrubs, trees, or other improvements or growths which in any way endanger or interfere with the construction, maintenance, or efficiency of its respective systems on said easements, and the City of McKinney and all public utilities shall at all times have the right of ingress and egress to and from and upon the said easement strips for the purpose of constructing, reconstructing, inspecting, patrolling, maintaining and adding to or removing all or parts of its respective systems without the necessity, at any time, of procuring the permission of anyone.




