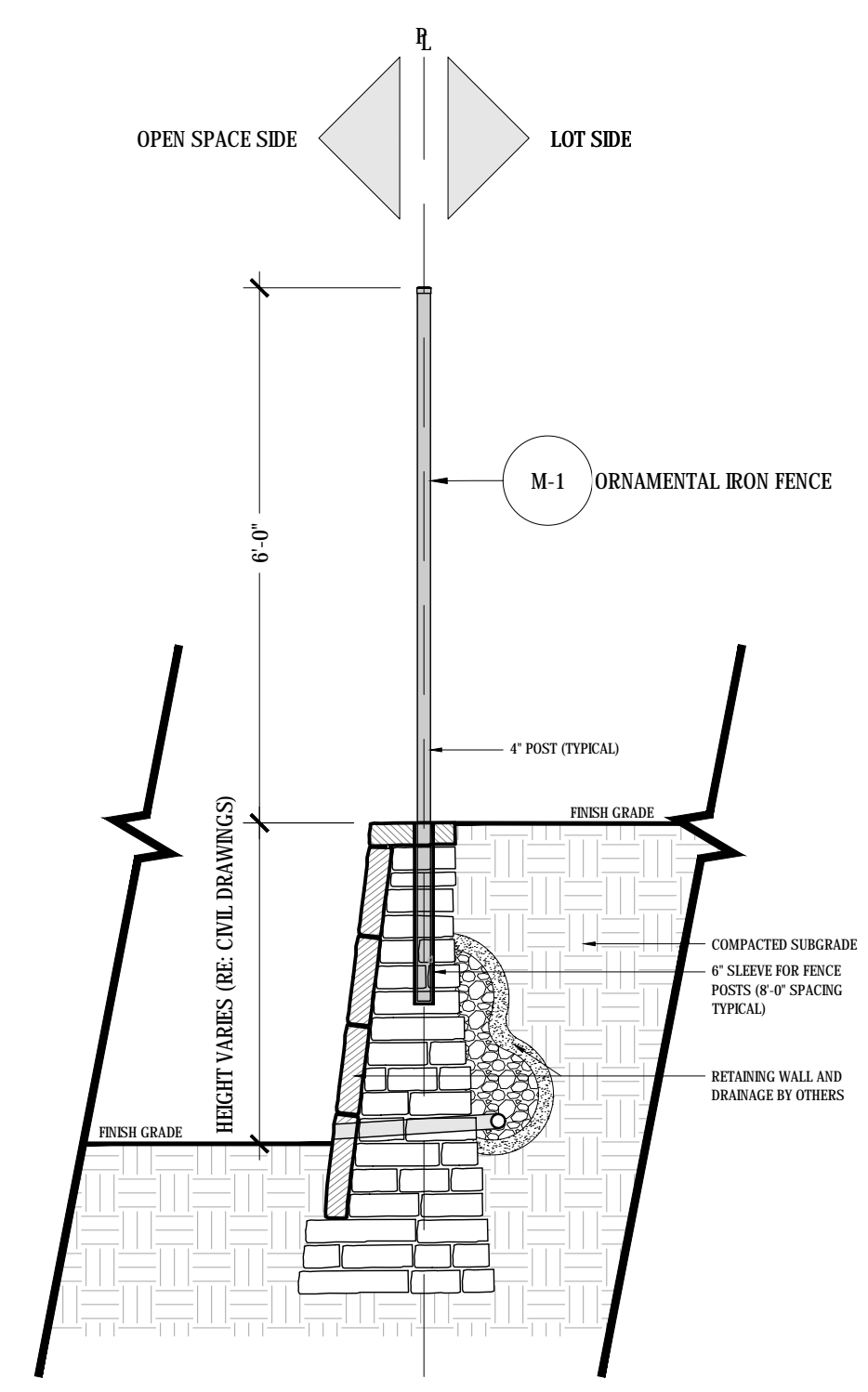

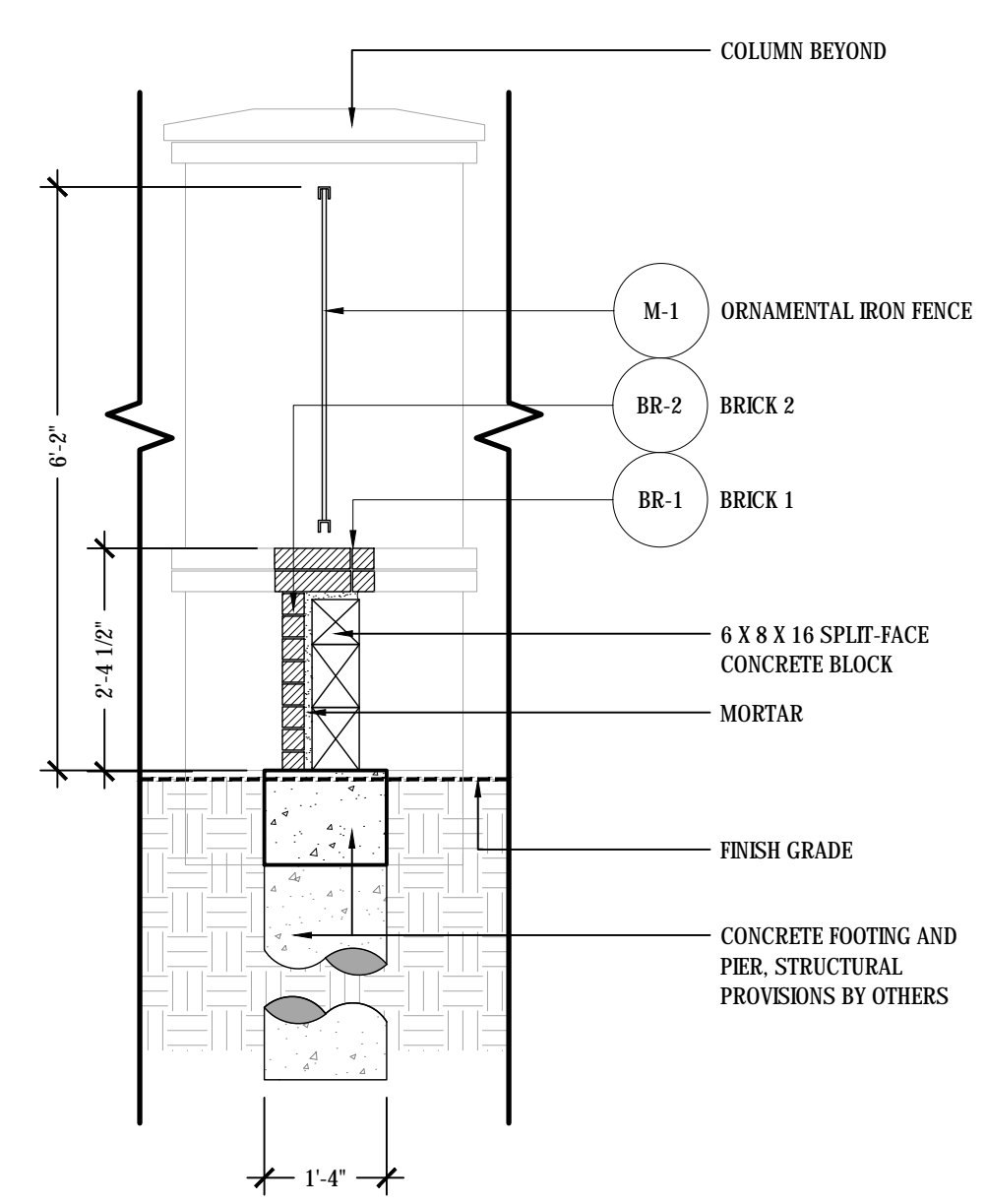
6' ORNAMENTAL SCREEN FENCE AT RETAINING WALL

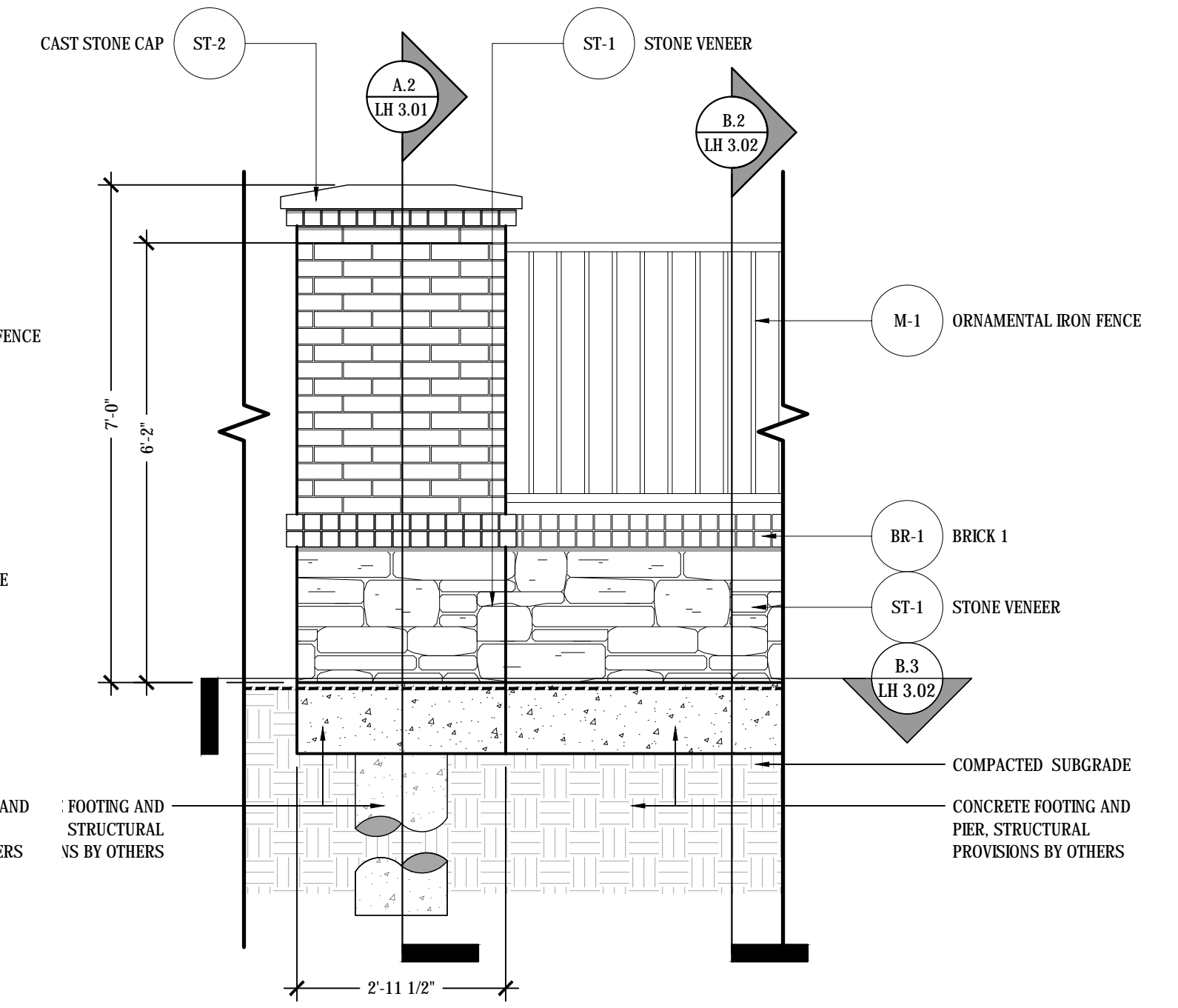

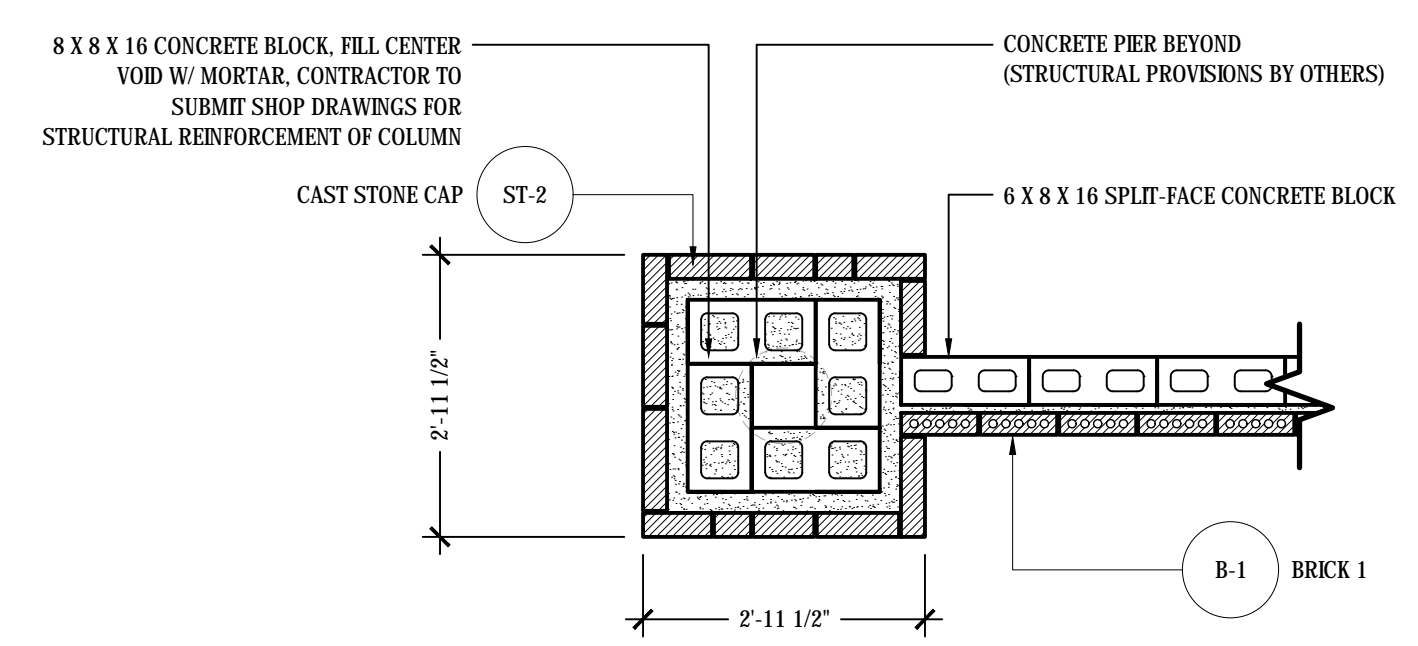

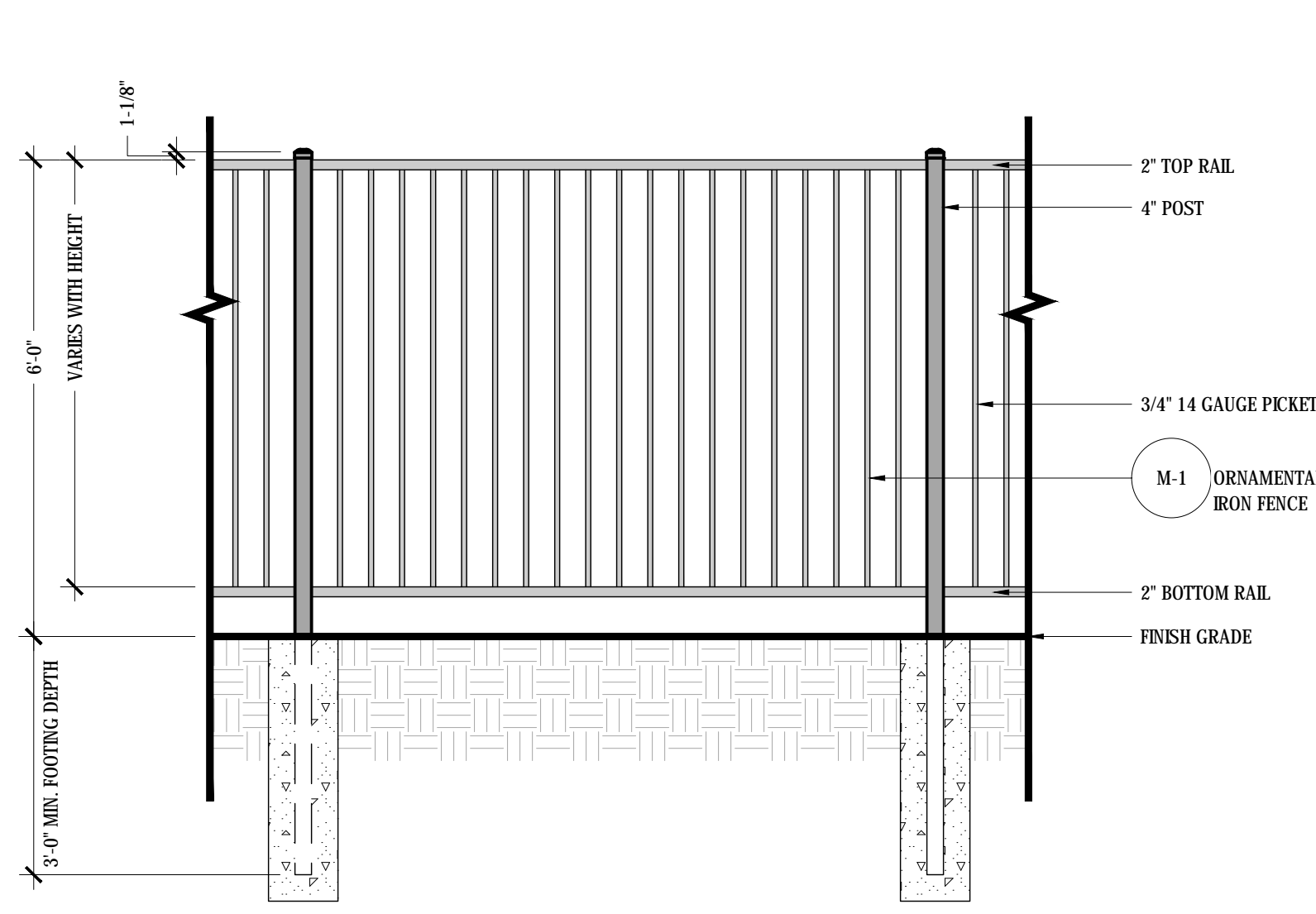
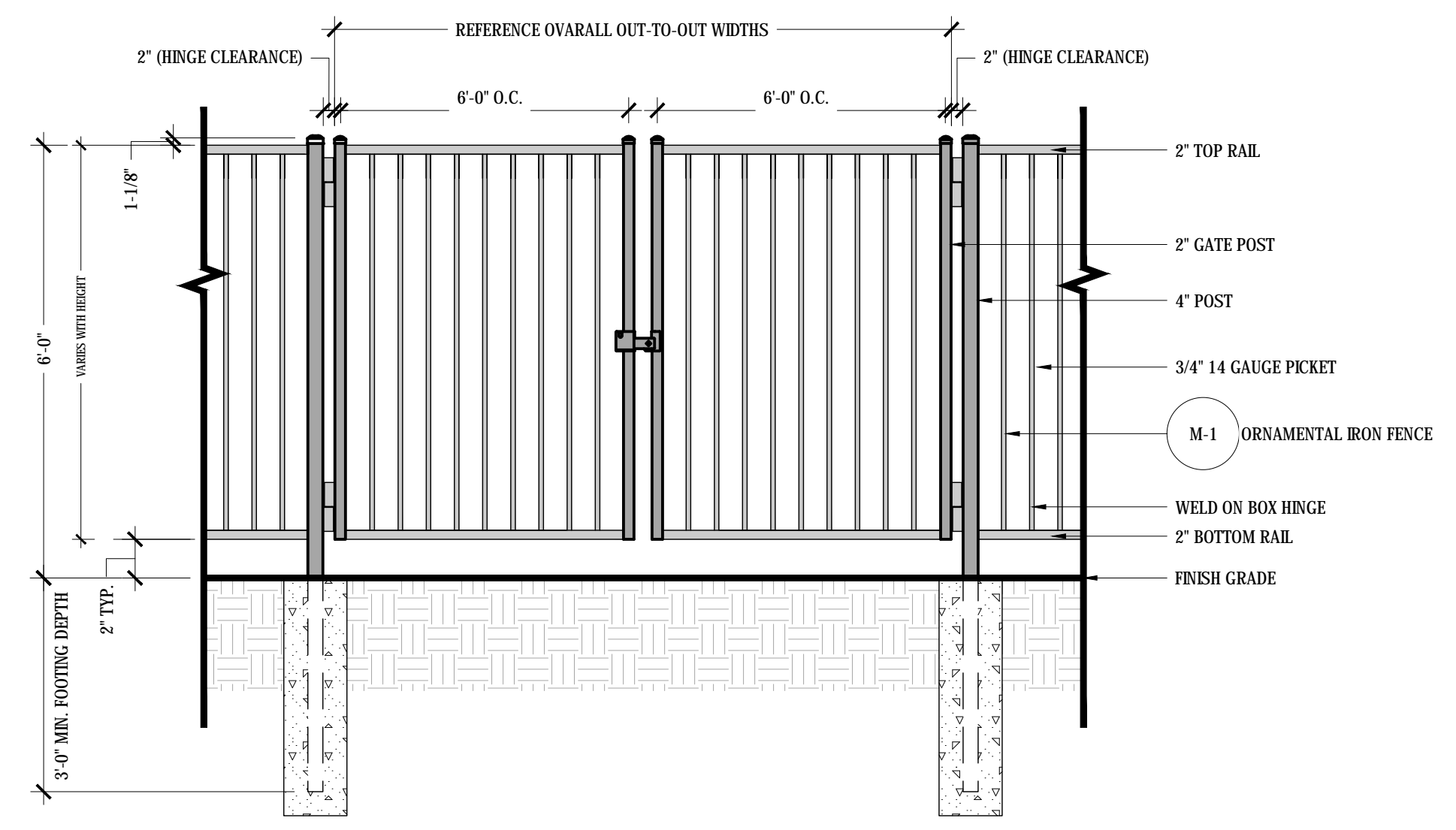
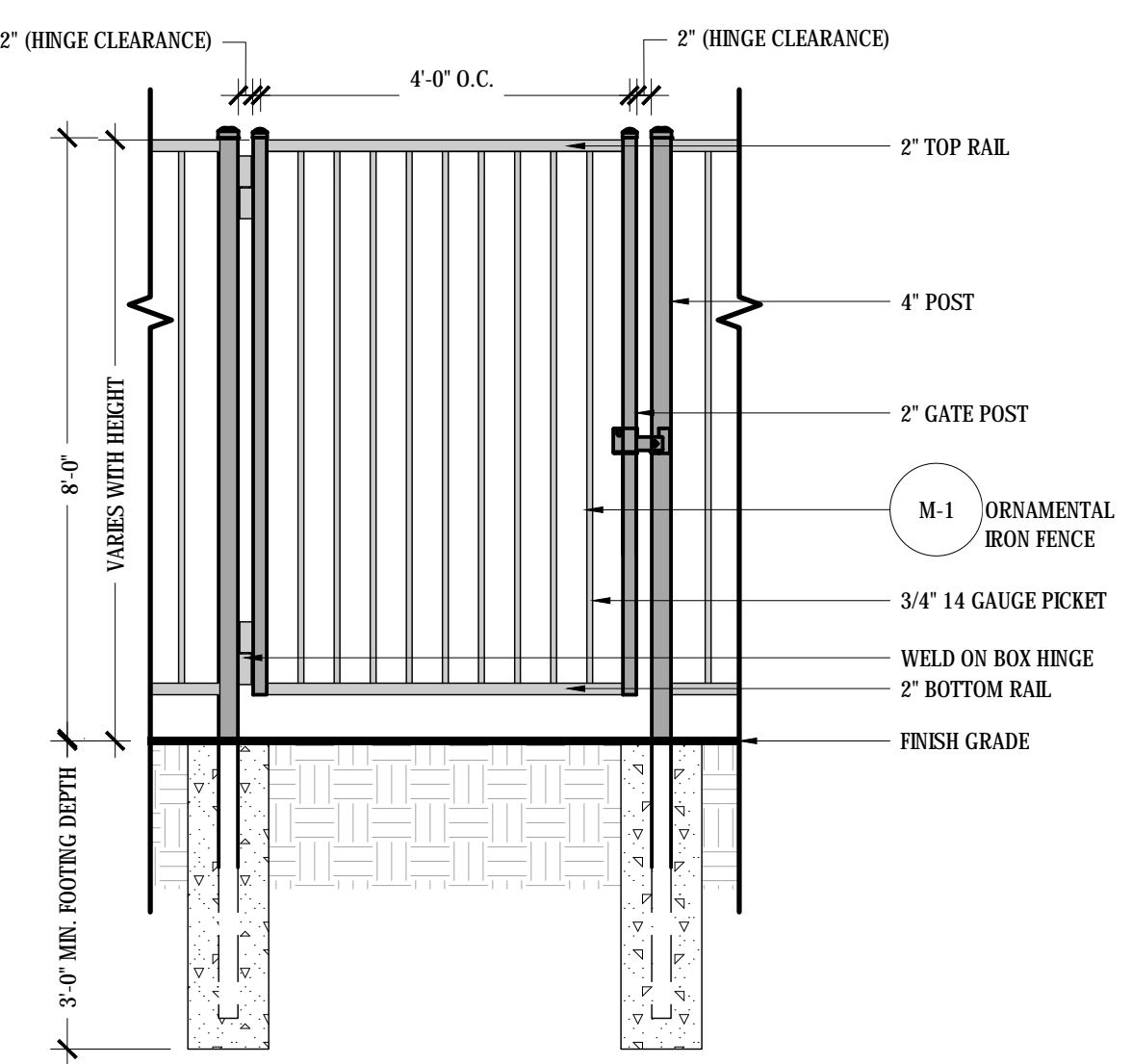
**B.1 ELEVATION - ENHANCED COLUMN, STONE WALL
