

**RESOLUTION NO. 2020-9-XX (R)**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
McKINNEY, TEXAS, APPROVING THE 2020-2021 COMMUNITY  
SUPPORT GRANT FUNDING ALLOCATIONS, AND PROVIDING  
AN EFFECTIVE DATE**

**WHEREAS**, the City Council established the Community Support Grant to support direct funding assistance for qualifying non-profit agencies serving the City of McKinney and its residents; and,

**WHEREAS**, the Community Grants Advisory Commission for the City of McKinney received grant applications from qualifying non-profit agencies; and,

**WHEREAS**, the Community Support Grant budget includes \$159,700 in funding to qualifying non-profit agencies; and,

**WHEREAS**, the Community Grants Advisory Commission held two public hearings and prepared recommendations for Council acceptance of the use of Community Support Grant funds; and,

**WHEREAS**, the City Council of the City of McKinney, Texas, finds and determines funding for the following qualifying non-profit agencies accomplishes a public purpose and municipal purpose for the City of McKinney.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY  
OF McKINNEY, TEXAS, THAT:**
