

ORDINANCE NO. 2011-10-___

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS DESIGNATING THREE-HOUR PARKING FOR THE SPACES ON TENNESSEE STREET BETWEEN CLOYD STREET AND DAVIS STREET; REMOVING THE NO PARKING ZONE ON DAVIS STREET BETWEEN TENNESSEE STREET AND MCDONALD STREET; AMENDING THE CODE OF ORDINANCES, CITY OF MCKINNEY, TEXAS; PROVIDING FOR THE PUBLICATION OF THE CAPTION OF THIS ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. That Section 62-415 (1) of the Code of Ordinances, City of McKinney, is hereby amended to read as follows:

(1) All of the portions of Virginia Street, Tennessee Street, Kentucky Street, and Louisiana Street surrounding the historic Collin County Courthouse, all that portion of such streets bounded on the west by Wood Street, on the north by Hunt Street, on the east by Chestnut Street and on the south by Cloyd Street; and including Louisiana Street from Chestnut Street to McDonald Street and Tennessee Street from Cloyd Street to Davis Street.

Section 2. That Section 62-382 – Davis Street (2), of the Code of Ordinances, City of McKinney is hereby amended to read as follows:

(2) Both sides of Davis Street between Kentucky Street and Tennessee Street.

Section 3. That Section 62-382 – Davis Street (3), and Section 62-382 – Davis Street (4), of the Code of Ordinances, City of McKinney, are hereby repealed.

Section 4. The Caption of this ordinance shall be published one (1) time in a newspaper having general circulation in the City of McKinney, Texas and shall be effective immediately upon its passage and publication, and after all necessary signs have been installed.

Section 5. Any person who violates any of the provisions of this ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2,000.00).
