

CITY COUNCIL REGULAR MEETING

MARCH 16, 2021

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, March 16, 2021 at 6:00 p.m.
