### CITY COUNCIL REGULAR MEETING

### **JUNE 17, 2014**

The City Council of the City of McKinney, Texas met in regular session in the Council Chambers of the Municipal Building on June 17, 2014 at 6:00 p.m.

14-573 Mayor Loughmiller called for Consideration/Discussion/Action on a Resolution Ratifying the Third Meet and Confer Agreement with the McKinney Fire Fighters Association. President of McKinney Fire Fighters Association IAFF Local 621 Steve Dorris stated that the process started with 47 proposals brought before the group. Agreement was reached on 38 of the proposals. Mr. Dorris thanked Deputy City Manager Jose Madrigal and his staff and recognized his team, Chris Mayzner, Austin Hendricks, Jim Floyd, Dean Crane, Jason Hockett, Chad Watson, Brad Watson, and Dirk Hedges. Mr. Madrigal thanked his staff for their hours of work, Assistant City Manager Rob Daake, Fire Chief Danny Kistner, Interim Human Resources Manager Kathryn Usery, Chief Financial Officer Rodney Rhoades, Assistant Fire Chief Chris Lowry, Assistant Fire Chief Tim Mock and Assistant to the City Manager Darrek Ferrell. Negotiations on the agreement began February 26<sup>th</sup> and concluded on May 27<sup>th</sup>. The agreement was ratified by the Association with a 91% approval on June 10, 2014. Mr. Madrigal presented the contract changes that included the contract term, base salary, sick leave payout, assignment pay, certification pay, mileage reimbursement, holiday buy back, and Fire Department catastrophic leave bank. Council unanimously approved the motion by Mayor Pro Tem Ussery, seconded by Council member Pogue, to approve a Resolution ratifying the Third Meet and Confer Agreement with the McKinney Fire Fighters Association. Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on a Resolution of the City Council of the City of McKinney, Texas, Determining No Objection to the Application of the "Lakes of Eldorado" to the Texas Department of Housing and Community Affairs (TDHCA), for 4% Tax Credits for the Rehabilitation of Multi-Family Units Within the Project. Affordable Housing Administrator Cristel Todd stated that the Lakes of Eldorado has applied to the Texas Department of Housing and Community Affairs (TDHCA) for 4% tax credits to rehabilitate the existing 220 units. North Star LLC of Eldorado is requesting a Resolution of no objection from Council to submit with their application to TDHCA. Housing & Community Development Manager Janay Tieken stated that the 4% tax credit comes from their IRS tax and they are allowed to take that money and use it toward the project. Applicant, Ms. Stephanie Baker, North Star representing Lakes of Eldorado, stated that the project will take approximately 18 months to complete. They will be spending \$18,000 per unit as well as repairing the parking lot and replacing the roof. Mayor Loughmiller called for public comment and there was none. Council unanimously approved the motion by Council member Don Day, seconded by Council member Randy P. Pogue, to close the public hearing and approve a Resolution of the City Council of the City of McKinney, Texas, determining No Objection to the application of the "Lakes of Eldorado" to the Texas Department of Housing and Community Affairs (TDHCA), for 4% Tax Credits for the Rehabilitation of Multi-Family units within the project. Planning Director Michael Quint stated that the applicant has requested that the public hearing be continued and the item tabled until the July 15, 2014 Council meeting. Mayor Loughmiller called for public comment and there was none. Council unanimously approved the motion by Council member Pogue, seconded by Mayor Pro Tem Ussery, to continue the public hearing and table the item until the July 15, 2014 meeting.

Mayor Loughmiller called for Consideration/Discussion/Action on the Request by JBI Partners, Inc., on Behalf of GA Land Development, L.P., for Approval of Preliminary-Final Plat for 441 Single Family Lots, 1 Multi-Family Residential Lot, and 18 Common Areas (Southern Hills at Craig Ranch), Being Fewer than 136 Acres, Located Approximately 240 Feet East of Custer Road and Approximately 325 Feet South of Collin McKinney Parkway. Director of Planning stated that the applicant is requesting to subdivide the property for multi-family and single-family residential uses. As proposed, the applicant has provided a layout that is not in conformance with the Street Design Manual, Master Thoroughfare Plan of the City's Comprehensive Plan, and the requirements of an associated development agreement with the City. As such, the applicant has requested a number of variances from the City's Subdivision Ordinance. Each of the requested variances have been discussed in greater detail below. Additionally, the applicant has requested that the associated development agreement and offsite portions of right-of-way be modified, but cannot be acted on with this request as it is not a part of The applicant is seeking a number of the preliminary-final plat. variances: a variance to the subdivision ordinance to waive the

requirement to dedicate a 120' right-of-way for a master planned arterial known as Craig Ranch Parkway, a variance to waive the requirement to construct the four lanes of that roadway as required by the subdivision ordinance, a variance waive the required maximum street tangent length of 600 feet, and a variance to allow deviations from the street section that are prescribed in the city's street design manual. Staff is not supportive of these variances. Staff feels the roadway needs to remain as it is in the Master Thoroughfare Plan as it serves as a regional reliever for traffic on Custer Road and Highway 121. Staff is recommending denial of this plat and denial of the variances requested. CIP and Traffic Manager Gary Graham stated that a four-lane arterial is necessary to relieve traffic and the future demand in this area. Mayor Loughmiller stated that when Council approved the rezoning of this tract from predominantly multifamily to single-family residential, he did not envision us creating a reliever for Custer Road where we have 12,000 cars a day running through the middle of a residential area. Mr. Quint stated that when this zoning came through, we were still working on the road classification. From a staff's perspective, we did anticipate at least a four-lane roadway going through here. At the time, the applicant wanted a two-lane roadway so we were trying to work with the applicant to allow the zoning to go forward. From a planning standpoint it does not make for as nice of a neighborhood when you are bisected by an arterial. Applicant, Mr. Bob Roeder, 1700 Redbud, Suite 300, McKinney, stated that they have looked at several layouts. The goal is to make this a connected community. The more cul-de-sacs there are, the more disconnected the community becomes. Council approved the motion by Mayor Pro Tem Ussery, seconded by Council member Pogue, to approve a Preliminary-Final Plat for 441 single family lots, 1 multi-family residential lot, and 18 common areas (Southern Hills at Craig Ranch), being fewer than 136 acres, located approximately 240 feet east of Custer Road and

approximately 325 feet south of Collin McKinney Parkway, with the following variances: approval of a variance to Section 142-105 (Improvements) of the Subdivision Ordinance waiving the requirement to dedicate 120 feet of right-of-way for a master planned major arterial roadway (Future Craig Ranch Parkway), as shown on the City's Comprehensive Plan - Master Thoroughfare Plan, approval of a variance to Section 142-105 (Improvements) of the Subdivision Ordinance waiving the requirement to construct four lanes of a master planned major arterial roadway (Future Craig Ranch Parkway), as shown on the City's Comprehensive Plan - Master Thoroughfare Plan, approval of a variance to Section 142-105 (Improvements) of the Subdivision Ordinance waiving the required maximum street tangent length of 600 feet, approval of a variance to Section 142-105 (Improvements) of the Subdivision Ordinance allowing deviation from the street section requirements prescribed by the City's Street Design Manual, to allow for a varying right-of-way width which accommodates a gatehouse, the applicant satisfy the conditions as shown on the Standard Conditions for Preliminary-Final Plat Approval Checklist; and prior to filing the plat for record: the applicant revise the plat to show required the detention, subject to the review and approval of the City Engineer, the applicant revise the plat to provide street names for all unnamed streets, and the applicant submit a modified development agreement subject to the review, approval, and execution by the City of McKinney, with a vote of 5-1-0, Council member Kever voting against.

Mayor Loughmiller called for a Public Hearing to Consider/Discuss/Act on a Resolution Adopting the State Highway 5 Corridor Context Sensitive Master Plan. Director of Planning Michael Quint presented the State Highway 5 Corridor Context Sensitive Master Plan. The SH 5 Master Plan serves as the conclusion to the SH 5 Corridor Context Sensitive Transportation Study (commonly referred to as the SH 5 Corridor Study),

which was undertaken in order to establish a context sensitive vision for the redesign of SH 5 through McKinney. The 16-month SH 5 Corridor Study included an analysis of existing conditions, identification of issues and opportunities along the corridor; a series of public outreach events; the development of design parameters and alternatives; and extensive coordination with the North Central Texas Council of Governments (NCTCOG) and Texas Department of Transportation (TxDOT). The Master Plan itself extends from the southern city limits to the northern city limits. Details were previously presented to Council on June 3. We are looking for Council's approval of this Master Plan tonight. Staff recommends approval of the item. Mayor Loughmiller called for public comment. Parkway in Prosper that has no name. As Council requested, a list of names has been provided in their packets. Mayor Loughmiller stated that unless we have consensus on a specific name, he would recommend that Council table this item. Council unanimously approved the motion by Council member Pogue, seconded by Council member Harris, to table this item until the July 15, 2014 meeting. Council unanimously approved amending the motion to change the date to the August 4, 2014 meeting.

14-576 Mayor Loughmiller called for Consideration/Discussion/Action on Filling the Vacant Position on the Planning and Zoning Commission. Council unanimously approved the motion by Council member Pogue, seconded by Council member Kever, to appoint Mark McReynolds to fill the vacant position on the Planning and Zoning Commission starting June 18, 2014 and ending on September 30, 2015.

Mayor Loughmiller called Citizen Comments and there were none.

Mayor Loughmiller called for Council and Manager Comments.

Council member Day did not have any comments.
