

ORDINANCE NO. 92-11-38

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, CALLING A SPECIAL ELECTION FOR JANUARY 16, 1993, TO ADOPT A SALES AND USE TAX; PROVIDING FOR A PROPOSITION TO BE SUBMITTED TO THE VOTERS OF THE CITY OF MCKINNEY; DESIGNATING A POLLING PLACE; MAKING PROVISION FOR THE MANNER AND CONDUCT OF THE ELECTION; PROVIDING FOR NOTICE AND PUBLICATION THEREOF; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF.

WHEREAS, the City Council of McKinney, Texas has determined that a special election should be held to ascertain whether the City Council of the City of McKinney shall be authorized to adopt a sales and use tax for the promotion and development of new and expanded business enterprises at the rate of 1/2 of one percent;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS,:

SECTION 1. That a special election shall be held on Saturday, January 16, 1993, at which election the following proposition shall be submitted:

PROPOSITION NUMBER 1

"SHALL the City Council of the City of McKinney, be authorized to adopt a sales and use tax for the promotion and development of new and expanded business enterprises at the rate of 1/2 of one percent, as provided by law?"

SECTION 2. That this election shall be held between the hours of 7:00 a.m. and 7:00 p.m. in accordance with the applicable provisions of Texas Election Code, and as may be required by law, all election materials and proceedings shall be printed in both English and Spanish.

SECTION 3. That all qualified voters may cast their ballots either "FOR" or "AGAINST" the aforesaid proposition, which shall appear on the ballot in substantially the following form:

PROPOSITION NUMBER 1:

"THE ADOPTION OF A SALES AND USE TAX FOR THE PROMOTION AND DEVELOPMENT OF NEW AND EXPANDED BUSINESS ENTERPRISES AT THE RATE OF 1/2 OF ONE PERCENT."

SECTION 4. That the McKinney City Hall, 222 North Tennessee Street, is hereby designated as the polling place for said election.

SECTION 5. That James Lane is hereby appointed Presiding Judge and Charlotte Jagours is hereby appointed Alternate Presiding Judge to conduct the special election; and said judges shall designate not less than two (2) nor more than eight (8) clerks to assist as shall be necessary and advisable, to be paid an hourly rate of five dollars (\$5.00) only until 9:00 p.m. on election day, with the judge who delivers the election returns to be paid twenty-five (\$25.00) for that service.

SECTION 6. That the method of voting to be used in the special election on Saturday, January 16, 1993, be voting machines with punchcard ballots.

- SECTION 7. That absentee voting by personal appearance be conducted Monday, December 28, 1992, through Tuesday, January 12, 1993, between the hours of 8:00 a.m. and 5:00 p.m. in the office of the City Secretary in the McKinney City Hall, with the method of voting to be voting machines with punchcard ballots.
- SECTION 8. That the Central Counting Station for the tabulation and counting of ballots for said election shall be located at the Collin County Courthouse, 210 South McDonald Street, McKinney, Texas.
- SECTION 9. That the official canvass, by the City Council, will be held on Monday, January 18, 1993, at 4:00 p.m. in the Council Chamber.
- SECTION 10. That a substantial copy of this Ordinance shall serve as proper notice of said election. Said notice, including a Spanish translation thereof, shall be posted at three (3) public places within the City and at the City Hall not less than twenty-one (21) full days prior to the date on which said election is to be held.
- SECTION 11. That this Ordinance shall be published on the same day in each of two successive weeks in a newspaper of general circulation in said City, the first of said publications to be made not sooner than thirty (30) full days prior to the election and not less than ten (10) full days prior to the date set for said election.
