CITY COUNCIL REGULAR MEETING

AUGUST 16, 2011

The City Council of the City of McKinney, Texas met in regular session in the Council Chambers of the Municipal Building on August 16, 2011 at 6:00 p.m.

Mayor Loughmiller called the meeting to order at 6:06 p.m. after determining a quorum was present. Invocation was given by Father Mathew Hoffman, St. Peters Episcopal Church. Mayor Loughmiller led the Pledge of Allegiance.

Mayor Loughmiller recessed the meeting into executive session at 6:10 p.m. per Texas Government Code Section 551.071 (2). Consultation with City Attorney on any Work Session, Special or Regular Session agenda item requiring confidential, attorney/client advice necessitated by the deliberation or discussion of said items (as needed) and Section 551.087 Discuss Economic Development Matter as listed on the posted agenda. Mayor Loughmiller recessed to the open session at 6:18 p.m.

Mayor Loughmiller called for Consideration/Discussion/Action on an 11-377 Ordinance Amending the Code of Ordinances by Repealing Chapter 70, Article VI, "Purchase and Sale of Certain Property for Resale or Salvage" in its Entirety and Adopting a new Chapter 70, Article VI to be Entitled "Secondary Metal Recyclers". Council member Kever stated that she is aware that the purpose of this ordinance is to make it more difficult for individuals to sell stolen metal and agrees that those are positive responses. Assistant Chief of Police Randy Roland stated that there are currently 3 scrap metal buyers within the City and the proposed ordinance would be consistent with the county wide regulations that have been put in place by the Collin County Commissioner's. Assistant Chief Roland stated that the city was approached by the County's Sheriff's Office about working together on this issue. Council unanimously approved the motion by Council member Harris, seconded by Council member Kever, to approve an Ordinance amending the Code of Ordinances by Repealing Chapter 70, Article VI, "Purchase and Sale of Certain Property for Resale or Salvage" in its entirety and adopting a new Chapter 70, Article VI to be entitled "Secondary Metal Recyclers". Caption reads as follows:

- Mayor Loughmiller stated that the Budget Update was covered during the work session and there is nothing new to add that was not covered in the work session.
- 11-382 Mayor Loughmiller stated that the Update on the Redistricting Process (if needed) was discussed at the work session. The public hearing and possible adoption of the redistricting plan will be held on September 6, 2011 at 6:00 p.m.
- 11-097M2 Mayor Loughmiller called for а Public Hearing for Consideration/Discussion/Action on the Request by the City of McKinney, for Approval of the Request to Amend Chapter 146 - Zoning Regulations of the Code of Ordinances, to Modify the Definition of a Church or Rectory to Allow a Temporary Not-for-Profit Housing Shelter as an Accessory Use, and Accompanying Ordinance. Senior Planner Brandon Opiela explained the proposed modification to the ordinance and stated that the changes would be to allow an onsite housing shelter which would provide no more than fourteen guests per evening and it would limit the accessory use to a maximum of 30 nights per calendar year. He stated that a nonprofit organization "Family Promise of Collin County" approached the city with providing a place for homeless people. Mr.

Opiela stated that the current ordinance only housed ministers, rabbis, priests, nuns, and similar staff personnel. He stated that the provision of temporary free overnight lodging allowed shall be limited to a maximum of 30 nights per calendar year, shall provide housing for no more than 14 guests per night, and shall require an annual permit for such accessory use issued by the Chief Building Official. Mr. Opiela stated that staff recommends approval of the amendment. Mr. Opiela stated that the churches would be required to meet the fire and safety conditions that other businesses have to meet. City Attorney Mark Houser stated that as long as the facilities meet the city's requirements then the city is protected from liability. City Manager Jason Gray stated that Staff has approached this as adding it to an existing use as opposed to adding a new use category or changing the definition that other uses currently fall under. Mr. Houser stated that there is no provision in the ordinance that would allow an organization to add more than the allowed 30 nights per year. Mayor Loughmiller called for public comment and there were none. Council unanimously approved the motion by Council member Ricchi, seconded by Council member Harris, to close the public hearing and approve the Ordinance amending Chapter 146 - Zoning Regulations of the Code of Ordinances, to modify the definition of a Church or Rectory to allow a Temporary Not-for-Profit Housing Shelter as an accessory use. Caption reads as follows:

Mayor Loughmiller called for Council and Manager Comments

Council member Ricchi did not have any comments.

Council member Day did not have any comments.

Council member Kever stated that she attended a transportation infrastructure summit in Irving. Ms. Kever presented a summary of a TxDOT budget comparison for 2010-2011 to 2011-201. Ms. Kever stated that the Council will be discussing public transportation at the September 6th work session. Ms. Kever stated that the RTC passed a HUD sustainable community regional planning grant and stated that McKinney is highlighted as a partner.

Council member Harris thanked the City Manager and City Staff on putting together a presentation on the budget and bringing forth a fiscally responsible balanced budget. Mr. Harris complimented the members of the City Council for doing a good job to bring forward a good redistricting proposal. He stated that the North Central Workforce Development Board will have a grand opening on August 25th at 10:30 a.m. for their new Workforce Office with Congressman Sam Johnson and Collin County Judge Keith Self in attendance.

Council member Brooks echoed the comments of Mr. Harris regarding the budget and the redistricting map and the great work of the City Manager and his staff. Mr. Brooks stated how proud he was to be a participant in the Blue Star Flag presentation tonight. Mr. Brooks stated that he appreciates all the tens of thousands of men and women who are in the armed services and fighting to defend our Country.

Mayor Pro-Tem Ussery thanked staff for what they do day in and day out. He stated that he appreciates all that everyone does to make this a fine place to live. Mr. Ussery thanked the Mayor for all that he does to move the City in a positive direction.

Mayor Loughmiller thanked the City Council for being a part of a great team. Mr. Loughmiller thanked everyone that participated at Victory Plaza for the WFAA-TV Daybreak broadcast of Party on the Plaza that featured the City of McKinney.

City Manager Gray thanked staff for their patience through the budget process. Mr. Gray expressed a debt of gratitude for the staff for allowing them to continue to serve. Mr. Gray encouraged everyone to make sure to check out our website for updates on items of interest. Mr. Gray stated that there will be a public input meeting regarding median landscaping. Mr. Gray invited everyone to attend the anniversary honoring the men and women who lost their lives on 9/11. Mr. Gray stated tonight we
