

ORDINANCE NO. 2020-09-____

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AMENDING THE CODE OF ORDINANCES OF THE CITY OF MCKINNEY, TEXAS, RELATING TO FEES, BY AMENDING THE CODE OF ORDINANCES SECTION 110-140, AND BY AMENDING APPENDIX A SCHEDULE OF FEES, IN PART, BY AMENDING SECTIONS 30-71, 30-85, 30-86, 30-175, 30-205, 66-21, 110-140, AND 110-230; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A REPEALER CLAUSE; PROVIDING FOR PUBLICATION OF THE CAPTION OF THIS ORDINANCE; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF

WHEREAS, the City Council of the City of McKinney, Texas, finds, determines, and declares that certain fees are necessary to provide for efficient government services; and

WHEREAS, the City Council of the City of McKinney, Texas, finds and determines that the current fees are insufficient to cover the costs of the respective services; and

WHEREAS, the City Council of the City of McKinney, Texas desires to adopt fees necessary for the City to provide good and efficient government for the benefit of the citizens of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS:

Section 1. That the findings set forth above are incorporated into the body of this Ordinance as if fully set forth herein.

Section 2. That Appendix A, entitled "Schedule of Fees", of the Code of Ordinances, City of McKinney, Texas, Section 30-71, is hereby amended to read as follows:

Appendix A, Section 30-71. U.S. customs fee.

Customs fee200.00

Customs Agents overtime fee, per Customs Agent for international flights arriving before or after normal business hours at McKinney National Airport350.00

Note: Normal business hours are defined as 8:00 a.m. to 5:00 p.m., Monday through Friday, excluding holidays. The amount of time and number of agents to process a flight is solely determined by U.S. Customs. Fees could be higher based on the resources assigned by U.S. Customs.

Section 3. That Appendix A, entitled "Schedule of Fees", of the Code of Ordinances, City of McKinney, Texas, Section 30-85, is hereby amended to read as follows:

Appendix A, Section 30-85. Fees for airport access cards, keys, and returned checks.

(a) A fee for the administrative and logistics cost of issuing airport security access cards to airport facilities.

(1) Initial issue40.00

(2) Replacement of lost access card50.00

(3) Replacement damaged access card (damaged card must be returned)20.00

(4) Bi-annual renewal (initial issuance fee applied if expired more than six (6) months)30.00

(b) A fee for the administrative and logistics cost of issuing airport keys to airport facilities.

(1) Replacement of lost, damaged, or stolen keys, or extra keys (first 2 new keys included with lease) provided for applicable rental spaces, per key10.00

(2) Replacement or rekeying of cores due to lost or stolen keys, per core (includes 2 keys per lock)100.00

(c) Fee for processing returned checks25.00

Section 4. That Appendix A, entitled "Schedule of Fees", of the Code of Ordinances, City of McKinney, Texas, Section 30-86, is hereby amended to read as follows:

Section 7. That Appendix A, entitled “Schedule of Fees”, of the Code of Ordinances, City of McKinney, Texas, Section 66-21, is hereby amended in part by adding:

Appendix A, Section 66-21. Administrative fees.

Filing a petition for expunction 100.00

Section 8. That the Code of Ordinances, City of McKinney, Texas, Section 110-140, is hereby amended to read as follows:

Sec. 110-140. - Same—Large service.

The cost of all water services and meter installations for meters larger than two inches or compound meters two inches and larger, installed and set by the city, shall be paid for at actual cost of labor, materials, equipment time and overhead.

All large service meters shall be charged a registration fee as established from time to time by ordinance to ensure compatibility with the city’s AMR/AMI reading system.

Section 9. That Appendix A, entitled “Schedule of Fees”, of the Code of Ordinances, City of McKinney, Texas, Section 110-140, is hereby added to read as follows:

Appendix A, Section 110-140. Same—Large service.

Meter register fee:

- (1) 3-inch meter or larger 150.00

Section 10. That Appendix A, entitled "Schedule of Fees", of the Code of Ordinances, City of McKinney, Texas, Section 110-230, is hereby amended to read as follows:

Appendix A, Sec. 110-230. Sewer service rates generally.

(1) Single-family dwelling accounts:

- a. The base monthly rate shall be
 - 1. Inside City 19.85
 - 2. Outside City 23.70
- b. The rate per 1,000 gallons up to 8,000 gallons, but not to exceed the winter average if applicable, shall be
 - 1. Inside City 5.55
 - 2. Outside City 6.65
- c. Utility customers shall be billed at actual metered water consumption not to exceed 8,000 gallons maximum until a winter average may be established. The winter average shall be established using the consumption for the months of December, January and February.

(2) Multifamily/commercial/industrial/governmental accounts:

a. The base monthly rate shall be:

- b. The rate per 1,000 gallons or any portion thereof shall be
 - 1. Inside City 5.55
 - 2. Outside City 6.65

(3) Municipal accounts:

- a. The rate per 1,000 gallons or any portion thereof
 - 1. Inside City 4.20
 - 2. Outside City 5.00

(4) Irrigation accounts:

- a. Meters used for irrigation purposes only shall not be billed sewer charges.

Section 11. That if any section, subsection, paragraph, sentence, phrase or clause of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall remain in full force and effect, and to this end, the provisions of this Ordinance are declared to be severable.

Section 12. That this Ordinance shall be cumulative of all other ordinances of the City and shall not repeal any of the provisions of said ordinances except in those instances where provisions of those ordinances are in direct conflict with the provisions of this Ordinance and such ordinances shall remain intact and are hereby ratified, verified and affirmed.

Section 13. The caption of this Ordinance shall be published one time in a newspaper having general circulation in the City of McKinney.

Section 14. This Ordinance shall become effective October 1, 2020.
