

ORDINANCE NO. 2011-06-___

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS MODIFYING SCHOOL ZONES AT VARIOUS SCHOOLS IN MCKINNEY; AMENDING THE CODE OF ORDINANCES, CITY OF MCKINNEY, TEXAS; PROVIDING FOR THE PUBLICATION OF THE CAPTION OF THIS ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. The City Council of the City of McKinney, Texas hereby amends Section 62–321 of the Code of Ordinances to read as follows:

Sec 62 – 321 Same – Speed.

The speed limit for vehicles traveling the streets within the Ogle Elementary School zone during the hours of 7:05 a.m. to 8:05 a.m. and 2:35 p.m. to 3:35 p.m., school days, shall be 20 miles per hour maximum.

Section 2. The City Council of the City of McKinney, Texas hereby amends Section 62–333 of the Code of Ordinances to read as follows:

Sec 62 – 333 Same – Speed.

The speed limit for vehicles traveling the streets within the Mooneyham Elementary School zone during the hours of 7:05 a.m. to 8:05 a.m. and 2:35 p.m. to 3:35 p.m., school days, shall be 20 miles per hour maximum.

Section 3. The City Council of the City of McKinney, Texas hereby amends Section 62–338 of the Code of Ordinances to read as follows:

Sec 62 – 338 Same – Speed.

The speed limit for vehicles traveling the streets within the Elliot Elementary School zone during the hours of 7:05 a.m. to 8:05 a.m. and 2:35 p.m. to 3:35 p.m., school days, shall be 20 miles per hour maximum.

Section 4. The City Council of the City of McKinney, Texas hereby amends Section 62–343.1 of the Code of Ordinances to read as follows:

Sec 62 – 343.1 Same – Speed.

The speed limit for vehicles traveling the streets within the Sonntag Elementary School zone during the hours of 7:05 a.m. to 8:05 a.m. and 2:35 p.m. to 3:35 p.m., school days, shall be 20 miles per hour maximum.

Section 5. The City Council of the City of McKinney, Texas hereby amends Section 62–341 of the Code of Ordinances to read as follows:

Sec 62 – 341 Same – Speed.

The speed limit for vehicles traveling the streets within the Scoggins Middle School zone during the hours of 7:40 a.m. to 8:40 a.m. and 3:25 p.m. to 4:25 p.m., school days, shall be 20 miles per hour maximum.

Section 6. The City Council of the City of McKinney, Texas hereby amends Section 62–242 of the Code of Ordinances to read as follows:

Sec 62 – 242 Same – Speed.

The speed limit for vehicles traveling the streets within the Roach Middle School zone during the hours of 7:30 a.m. to 8:30 a.m. and 3:30 p.m. to 4:30 p.m., school days, shall be 20 miles per hour maximum.

Section 7. The City Council of the City of McKinney, Texas hereby amends Section 62–310 (1) of the Code of Ordinances to read as follows:

(1) On Joplin Drive beginning 500 feet north of Virginia Parkway and extending northward along Joplin drive to 440 feet south of Lea Drive.

Section 8. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, after all the necessary signs and markings have been installed, and it is accordingly so ordained.

Section 9. Any person who violates any of the provisions of this Ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2,000)
