#### CITY COUNCIL REGULAR MEETING

# **DECEMBER 7, 2010**

The City Council of the City of McKinney, Texas met in regular session in the Council Chambers of the Municipal Building on December 7, 2010 at 6:00 p.m.

Planning Director Jennifer Cox stated that the Community Support Grant Funding is given to organizations which can be reasonably categorized under the heading of providing a public service that promotes the health, safety and welfare of McKinney residents. The Community Grants Advisory Board received applications from 24 area non-profit agencies requesting a total of \$647,622 in funding, when only \$119,700 is available. Council approved the motion by Mayor Pro-Tem Huff, seconded by Council member Brooks, to approve a Resolution Approving the 2010-2011 Community Support Grant Funding Allocations, with a vote of 6-0-1, Council member Kever abstaining. Council unanimously approved the motion by Council member Ussery, seconded by Council member Brooks, to table this item until the February 15, 2011 meeting.

Mayor Loughmiller called for Action on Executive Session Items. Council unanimously approved the motion by Council member Brooks, seconded by Mayor Loughmiller, to approve a settlement agreement that was recommended to Council by our Attorneys for a global settlement with all parties to the Gateway matter and the Gateway litigation.

Mayor Loughmiller called for Council and Manager Comments and Liaison Reports

Council member Brooks stated that the Veterans Day Ceremony was a great event at the future site of the Veterans Memorial that will be under construction in early 2011. The McKinney Economic Development Corporation met this morning and approved their new strategic plan and a few small incentive agreements.

Council member Ussery thanked staff for all they do day in and day out for making this a wonderful City to live. Mr. Ussery wished everyone a joyous holiday season.

Mayor Pro-Tem Huff stated that the Christmas Tree Lighting was excellent event that had a large attendance. There were more people in downtown area at this event than for any other event that has been held in downtown.

Council member Ricchi stated that McKinney was selected as one of six Cities to be highlighted as a Big Texas Adventure. Mr. Ricchi stated that there will be a Bloomin and Boomin event that will be held June 10 through July 4<sup>th</sup>. The City organizations have pooled their money together to place an ad in the Southwest Airlines magazine that will be highlighted during the Superbowl. Mr. Ricchi wished everyone good health, family memories, caring friends, and God's blessing.

Council member Day wished everyone a great holiday season.

Council member Kever wished everyone a Merry Christmas. Ms. Kever stated that the McKinney Arts Commission has been working on some policy issues. Ms. Kever stated that the City Council would begin discussion tonight during Executive Session regarding the hiring of a new City Manager.

Mayor Loughmiller stated that a meeting will be held on December 13<sup>th</sup> with County Commissioner Joe Jaynes and County Engineers to discuss the Outer Loop project and the. Council's consensus of a southern preferred route through City of McKinney. On January 4, 2011, a Resolution will be before the Council for consideration to support a southern route. This decision is ultimately Collin County's but it is important for the County to know what the City's interest and desires are as it relates to the construction of the outer loop. Mr. Loughmiller stated that this is the last meeting of the City Council for 2010. Mayor Loughmiller wished everyone a Merry Christmas and a Happy New Year. Mr. Loughmiller reminded everyone that charity begins at home and that there are a number of organizations at this time of year that need our support.

City Manager Chaffin thanked all City employees who work hard all year round to serve our citizens. Mr. Chaffin wished everyone a safe and Happy Christmas.

Mayor Loughmiller called for Citizen Comments and there were none.
