## ORDINANCE NO. 2013-02-\_\_\_

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS ESTABLISHING A SPEED ZONE ON WILMETH ROAD; AMENDING THE CODE OF ORDINACES, CITY OF MCKINNEY, TEXAS; PROVIDING FOR THE PUBLICATION OF THE CAPTION OF THIS ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY **CLAUSE** 

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

Section 1. Section 62-117 of the Code of Ordinances, City of McKinney, Texas, is hereby amended by deleting the following:

> Wilmeth Boulevard, zone 2, which extends from Lake Forest Drive to Ridgeknoll Avenue, a speed limit of 40 miles per hour.

Wilmeth Road, zone 1, which extends from State Highway 5 to Highpoint Boulevard, a speed limit of 40 miles per hour.

Wilmeth Road, zone 2, which extends from Highpoint Boulevard to Hardin Boulevard, a speed limit of 40 miles per hour.

Section 62-117 of the Code of Ordinances, City of McKinney, Texas, is Section 2. hereby amended to read as follows:

> Wilmeth Road, zone 1, which extends from State Highway 5 to Hardin Boulevard, a speed limit of 40 miles per hour.

> Wilmeth Road, zone 2, which extends from Ridgeknoll Avenue westward approximately 1,250 feet to the existing city limits, a speed limit of 40 miles per hour.

- Section 3. The caption of this ordinance shall be published one (1) time in a newspaper having general circulation in the City of McKinney, Texas and shall be effective immediately upon its passage and publication, and after all necessary signs have been installed.
- Any person who violates any of the provisions of this ordinance shall be Section 4. guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2,000.00).
