MINUTES CITY OF MCKINNEY, TEXAS COMMUNITY GRANTS ADVISORY COMMISSION THURSDAY, NOVEMBER 18, 2010, 6:30 PM COMMUNITY SERVICES ANNEX B CONFERENCE ROOM

The Community Grants Advisory Commission (CGAC) of the City of McKinney, Texas, met in regular session in the Community Services Annex B Conference Room, 314 South Chestnut, Suite 101 on Thursday, November 18, 2010 at 6:30 p.m.

Commission members present were Aaron McMahon, Brenda Carter, William Wehunt and Kimberly Hubbard-Hall. Jennifer Cox, Director of Planning and Interim Manager of Community Services, Shirletta Best, CDBG Administrator, and Christine Lawton, CDBG Coordinator, represented City staff. Ada Simmons, Celso Martinez and Rachelle Campbell were unable to attend the meeting.

Chairperson McMahon called the meeting to order at 6:50 p.m.

Chairperson McMahon asked if the commission members had changes or additions to the minutes from the October 27 and October 28, 2010 public hearings. Following the need for two changes as stated by Ms. Carter, Chairperson McMahon asked for approval of the minutes as amended. Mr. Wehunt made a motion to approve and Ms. Carter seconded. The motion passed unanimously 4-0.

Next on the agenda was the consideration, discussion, and action for all proposed FY 2010-11 Community Support Grant funding requests. The amount of total grant funding pool for the fiscal year was \$119,700. Each Commissioner prepared funding recommendations for each agency, prior to the deliberations meeting.

The funding amounts were inserted into an Excel spreadsheet, which averaged individual recommendations into a grant award amount for consideration.

After considerable discussion, the Commission confirmed the final recommendations and reached the following consensus:
