

ORDINANCE NO. 2014-11-\_\_\_

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS DESIGNATING RESERVED PARKING FOR LAW ENFORCEMENT ONLY NEAR THE MCKINNEY POLICE STOREFRONT IN MCKINNEY; AMENDING THE CODE OF ORDINANCES, CITY OF MCKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE**

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

Section 1. The City Council of the City of McKinney, Texas hereby repeals Section 62-420 of the Code of Ordinances.

Section 2. The City Council of the City of McKinney, Texas hereby amends the Code of Ordinances by adding Section 62-420, which will read as follows:

**Sec 62-420 Spaces Designated for Parking of Law Enforcement Only**

It shall be unlawful for any person to park a motor vehicle in the following locations, except the parking of law enforcement vehicles shall be permitted.

- (1) On the north side of Davis Street beginning at the intersection of Chestnut Street and extending westward to the intersection of Johnson Street
- (2) On the west side of Kentucky Street beginning at a point 20 feet north of Cloyd Street and extending southward 60 feet to encompass three parallel parking spaces to a point 40 feet south of Cloyd Street
- (3) A single parking space adjacent to the north side of the McKinney Police Storefront and to the west of Kentucky Street in the parking lot near the intersection of Kentucky Street and Davis Street

Section 3. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, after all the necessary signs and markings have been installed, and it is accordingly so ordained.

Section 4. Any person who violates any provisions of this Ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2000).
