

RESOLUTION _____

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, PROVIDING FUNDING FOR THE SUPPORT OF ARTS GROUPS FROM THE GENERAL FUND IN AN AMOUNT NOT TO EXCEED \$185,000.00; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Arts Commission for the City of McKinney received grant applications from various arts groups totaling \$233,891.50; and,

WHEREAS, the 2013-14 budget for the City of McKinney includes \$185,000.00 for the support of arts groups operating in the City of McKinney; and

WHEREAS, the City Council of the City of McKinney, Texas, finds and determines the following funding accomplishes a public purpose and municipal purpose for the City of McKinney.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. The foregoing recitals are hereby found to be true and correct legislative findings of the City of McKinney, Texas, and are fully incorporated into the body of this Resolution.
