This written withdrawal of protest must bear the original signatures of ONLY the owners of property that are: (1) subject to the proposed zoning change; or, (2) situated within 200 feet of the property which is the subject of the proposed zoning change. The individual(s) collecting the signatures contained on the pages submitted with and made a part of this Zoning Change Written Protest Withdrawal form shall be required to complete the Zoning Change Written Protest Withdrawal Signature Witness Affidavit. (Please note that individual owners of eligible property may submit an individual Zoning Change Written Protest Withdrawal form, which form is available from the City, rather than sign this form.)
