AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, AUTHORIZING A CERTAIN BUDGET AMENDMENT PERTAINING TO THE FISCAL YEAR 2021-2022 ANNUAL BUDGET FOR THE McKINNEY SILOS ART MURAL PROJECT (GR2109); AND PROVIDING FOR AN EFFECTIVE DATE HEREOF

WHEREAS, as required by the City Charter, the City Manager has prepared an amendment to certain appropriations and expenditures / expenses in the Fiscal Year 2021-2022 Annual Budget and submitted same to the City Council for its approval and a true and correct copy is attached.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, a Budget Amendment pertaining to the Fiscal Year 2021–2022 Annual Budget is hereby authorized and approved.
- Section 2. The budget shall be amended by appropriating \$398,000 from the Hotel/Motel Fund balance and transferring it to the Public Art Fund.
- Section 3. The budget shall be amended by transferring \$90,000 from the TCA Grant to the Public Art Fund for the McKinney Silos Art Mural Project (GR2109).
- Section 4. The budget shall be amended by appropriating \$488,000 in the Public Art Fund for the McKinney Silos Art Mural Project (GR2109).
- Section 5. This Ordinance shall become effective from and after its adoption and is so ordained.
