## ORDINANCE NO. 2014-10-\_\_\_

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS RENAMING MILLERD POND DRIVE BETWEEN ROSEBURY CIRCLE TO STONEBRIDGE DRIVE TO MILLARD POND DRIVE IN McKINNEY; AMENDING THE CODE OF ORDINANCES, CITY OF McKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE

- **WHEREAS**, Millard Pond Drive within the Stratford Manor Addition was dedicated to the City of McKinney by plat; and
- WHEREAS, the street name was inadvertently misspelled on the plat; and
- **WHEREAS**, Ordinance No. 2002-11-110 changed the name of Millard Pond Drive to Millerd Pond Drive within the Stratford Manor Addition; and
- **WHEREAS**, there is a request to change the name of the Millerd Pond Drive to Millard Pond Drive between Rosebury Circle and Stonebridge Drive; and
- **WHEREAS**, changing the street name of Millerd Pond Drive to Millard Pond Drive will require the Plat Record filed for Wyndsor Grove to be changed.

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. The City Council of the City of McKinney, Texas hereby changes the name of Millerd Pond Drive located between Rosebury Circle and Stonebridge Drive to Millard Pond Drive
- Section 2. The City Council of the City of McKinney, Texas hereby changes the name of Millerd Pond Drive to Millard Pond Drive within the Wyndsor Grove as shown in the Record Plat filed in Volume N Page 848 of the Plat Records.
- Section 3. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, after all the necessary signs and markings have been installed, and it is accordingly so ordained.
