AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, AUTHORIZING A CERTAIN BUDGET AMENDMENT PERTAINING TO THE FISCAL YEAR 2015-2016 BUDGET AND THE 2016 – 2020 CAPITAL IMPROVEMENTS PROGRAM; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF

WHEREAS, as required by the City Charter, the Interim City Manager has prepared an amendment to certain appropriations and expenditures / expenses in the 2015-2016 Budget and the 2016 – 2020 Capital Improvements Program and submitted same to the City Council for its approval and a true and correct copy is attached.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, the fiscal year 2015-2016 Budget Amendment as attached, is hereby authorized and approved.
- Section 2. The budget shall be amended by adding \$75,000 to the budget and allowing a transfer of \$75,000 from the Parkland Dedication Zone 3 Fund to the Parks Construction Fund.
- Section 3. The budget shall be amended by appropriating \$75,000 in the Park Construction Fund to CIP project PK2262 for the Land Acquisition Project.
- Section 4. This Ordinance shall become effective from and after its adoption and is so ordained.
