ORDINANCE NO. 2013-09-XXX

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, AMENDING ORDINANCE NO. 1270 OF THE CITY OF McKINNEY, TEXAS; SO THAT AN APPROXIMATELY 5.25 ACRE PROPERTY, LOCATED APPROXIMATELY 900 FEET NORTH OF ELDORADO PARKWAY AND ON THE EAST SIDE OF ALMA ROAD, IS REZONED FROM "PD" – PLANNED DEVELOPMENT DISTRICT TO "PD" – PLANNED DEVELOPMENT DISTRICT, GENERALLY TO MODIFY THE DEVELOPMENT STANDARDS; PROVIDING FOR SEVERABILITY; PROVIDING FOR INJUNCTIVE RELIEF, PROVIDING FOR NO VESTED INTEREST; PROVIDING FOR THE PUBLICATION OF THE CAPTION OF THIS ORDINANCE; PROVIDING FOR A PENALTY FOR THE VIOLATION OF THIS ORDINANCE; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF

- WHEREAS, the City of McKinney has considered the rezoning of an approximately 5.25 acre property, located approximately 900 feet north of Eldorado Parkway and on the east side of Alma Road, which is more fully depicted on Exhibits "A" and "B", attached hereto, from "PD" Planned Development District to "PD" Planned Development District, generally to modify the development standards; and,
- **WHEREAS**, after due notice of the requested rezoning as required by law, and the required public hearings held before the Planning and Zoning Commission and the City Council of the City of McKinney, Texas, the City Council is of the opinion that the change in zoning district should be made.

NOW THEREFORE BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS:

- Section 1. Ordinance No. 1270 is hereby amended in order to rezone an approximately 5.25 acre property, located approximately 900 feet north of Eldorado Parkway and on the east side of Alma Road, which is more fully depicted on Exhibits "A" and "B", attached hereto, from "PD" Planned Development District to "PD" Planned Development District, generally to modify the development standards.
- Section 2. Use and development of the subject property, more fully depicted on Exhibits "A" and "B", shall develop in accordance with the "MF-1" Multiple Family Residential Low Density District of the Zoning Ordinance, and as amended, except as follows:
 - a. The development of the subject property shall generally conform to the attached site and landscape plan exhibits, as shown on Exhibits "C" and "D", respectively.
 - b. Multi-family residential shall be limited to Multiple Family Dwelling, Senior (Senior Apartment), as defined in Section 146-46 (Definitions) of the Zoning Ordinance.
 - c. Maximum building height shall be one (1) story.
 - d. Windows within 150 feet of a property line shall be allowed to be oriented towards adjacent single family residences.
 - e. A masonry screening wall shall not be required along all side and rear property lines.
 - f. A maximum of 34 dwelling units shall be permitted as shown on Exhibit "C".

- g. The character of any multi-family residential development shall generally conform to the attached elevations, as shown on Exhibit "E", and shall also be subject to the Architectural and Site Standards section of the Zoning Ordinance, except as amended herein.
- Section 3. If any section, subsection, paragraph, sentence, phrase or clause of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall remain in full force and effect, and to this end, the provisions of this Ordinance are declared to be severable.
- Section 4. It shall be unlawful for any person, firm or corporation to develop this property, or any portion thereof, in any manner other than is authorized by this Ordinance, and upon conviction therefore, shall be fined any sum not exceeding \$2,000.00, and each day that such violation shall continue shall be considered a separate offense. These penal provisions shall not prevent an action on behalf of the City of McKinney to enjoin any violation or threatened violation of the terms of this Ordinance, or an action for mandatory injunction to remove any previous violation hereof.
- Section 5. That no developer or property owner shall acquire any vested interest in this Ordinance or specific regulations contained herein. The ordinance, and the subsequent site plans (if any) and regulations may be amended or repealed by the City Council of the City of McKinney, Texas, in the manner provided by law.
- Section 6. The caption of this Ordinance shall be published one time in a newspaper having general circulation in the City of McKinney, and shall become effective upon such publication.
