A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF McKINNEY, COLLIN COUNTY, TEXAS, AUTHORIZING THE DEPUTY CITY MANAGER TO EXECUTE AN AMENDED PROFESSIONAL SERVICES CONTRACT WITH H.W. LOCHNER, INC. FOR ENVIRONMENTAL SITE ASSESSMENTS AND ASSOCIATED SUPPORT FOR BROWNFIELD GRANT ADMINISTRATION; PROVIDING AN EFFECTIVE DATE

- **WHEREAS**, the Environmental Protection Agency (EPA) Brownfields Program empowers states, cities and other stakeholders in economic development and environmental management to work together to assess, safely clean up, and sustainably reuse brownfields; and
- WHEREAS, the City of McKinney was awarded Brownfields Assessment Grant Program funding from the Environmental Protection Agency through the FY 2010 Program Cycle; and
- WHEREAS, through the FY 2010 Brownfields Assessment Program Cycle, the City of McKinney executed a professional services contract with H.W. Lochner, Inc. for an amount not to exceed \$386,000 in support of environmental services associated with Environmental Site Assessments; and
- **WHEREAS,** through the FY 2010 Brownfields Assessment Program, \$14,000 was allocated for travel, training and supplies associated with the establishment and operation of the McKinney Brownfields Program; and
- WHEREAS, The FY 2010 Program Cycle will expire in September 2014 and the McKinney Brownfields Program has utilized approximately 90 percent of approved funding; and
- WHEREAS, in order to make best use of remaining grant funding, the Environmental Protection Agency has approved a reallocation of remaining funds for professional services in support of Environmental Site Assessments; and
- **WHEREAS,** it is in the best interest of the citizens of the City of McKinney that a contract amendment be executed with H.W. Lochner, Inc. in support of professional services provided in for completion of Environmental Site Assessments.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

- Section 1. The City Council of the City of McKinney, Texas hereby authorizes the Deputy City Manager to execute an amended professional services contract with H.W. Lochner, Inc. for an amount not to exceed \$394,030.
- Section 2. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
