On December 26, 2013, you applied for a Gaming Machine permit ("Permit") from the City of McKinney ("City") for Lucky Gems. The requirements for a Permit are set forth in the City's Code of Ordinances ("City Code"), specifically Article II of Chapter 22 "Amusements." Section 22-23 (b) of the City Code specifically states that "The city secretary shall not issue or renew a permit under this article and shall suspend or cancel a permit if it be determined that the applicant or permittee is indebted to the city for any fee, costs, penalties, or delinquent taxes."

According to your Utility Account at 5609 White Pine Drive, you are delinquent in fees owed to the City of McKinney. Based on this delinquency, your gaming application for Lucky Gems is denied.

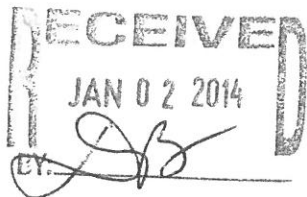
