will be on a 12-month fiscal year basis. The total tax increment received

into the TIRZ No. 2 fund totals \$160,607 consisting of the following:

\$17,896 - 100% of captured City of McKinney real and business personal

property (ad valorem) tax, \$3,833 - 50% of captured Collin County real

and business personal property (ad valorem) tax, and \$138,878 - 100%

of captured City of McKinney sales & use tax. Board member Pogue

requested that future reports include a comparison of catalyst project

expenditures and prior year expenditures. Board members unanimously

member Harris, to approve the 2013 Annual Report for Tax Increment
