Chairman Tutson then called for the next item on the agenda which was to consider/discuss/act on establishing Payment Standards (10.44). Ms. Bentley presented the Board with the compilation of information used to establish the payment standards to meet compliance with the Small Area FMR initiative. The agency has contracted with NELROD, an agency consortium, to provide recommended standards based on the agency's budget and utilization. The agency has met with HUD Field Representatives for technical assistance with utilization. In addition the agency has consulted with other Housing Authorities participating in the program. And the Housing Inspector, Laverne Gary compiled the agencies data regarding unit comparables for each zip code. At this point the payment standards are compiled into four groupings. NELROD will utilize our current payments to assist us with determining the final standards. After much discussion, no action was needed at the time.

(10.45) Ms. Bentley advised the Board that the item was being presented to address the changes in leadership. Commissioner Stockford motioned to approve the item.
