11-416 Mayor Loughmiller called for Consideration/Discussion/Action on a Resolution Authorizing the City Manager to Execute an Interlocal Agreement with Texoma Area Paratransit Systems, Inc. (TAPS) for Transit Services in Support of the McKinney Job Access/Reverse Commute (JA/RC) Shuttle Bus Service. Senior Planner Jennifer Arnold stated that under the federal Job Access/Reverse Commute Program (JA/RC Program), the City of McKinney has the opportunity to implement a three-year pilot program to provide round-trip commuter shuttle bus service between McKinney and the Dallas Area Rapid Transit (DART) Parker Road Rail Station in Plano, Texas (known as the McKinney JA/RC Shuttle Bus Service). The Resolution authorizes the City Manager to execute an Interlocal Agreement with Texoma Area Paratransit Systems, Inc. (TAPS) for transit services in support of the McKinney JA/RC Shuttle Bus Service. Ms. Arnold stated that TAPS would be providing four round trip services each day. TAPS agreed to provide 3 additional buses from Grayson County if the demand was greater than the two buses could handle. Ms. Arnold stated that prior to the end of the three years, staff would be evaluating the demand to see if additional funding options

should be explored for extending the service. Council unanimously approved the motion by Council member Kever, seconded by Mayor Pro-Tem Ussery, to approve a Resolution authorizing the City Manager to execute an Interlocal Agreement with Texoma Area Paratransit Systems, Inc. (TAPS) for Transit Services in support of the McKinney Job Access/Reverse Commute (JA/RC) Shuttle Bus Service. Caption reads as follows:

11-417 Mayor Loughmiller called for Consideration/Discussion/Action on a Resolution Authorizing the City Manager to Negotiate a Contract with the Matthews Southwest for Development Services Related to the Gateway Project Including the Hotel-Events Center and the Office-Retail Area. City Manager Jason Gray stated this is a culmination of the request for proposal process that staff has been working on for the last six months. Mr. Gray stated that staff is considering looking into a short term letter agreement to talk specifically, within the next 60 days, about what is the best possible method of moving forward with the hotel and event center. The letter of agreement includes a provision that we have the flexibility and the possibility of retaining a different hotel specific developer on the project that would work in coordination with Mathew Southwest in the event that we deem that is appropriate. Mr. Gray stated that the first 60 days would be to bring forward some very specific proposals, options and advice on the best way to move forward with the hotel and event center that would include the brand of the hotel, some of the operations, financing, the methodology, and the timeframe that it would be developed. Mr. Gray stated over the next 60 days the remaining 70 acres will be looked at to analyze the best way to move forward with the

overarching project as a whole. Recommendations will be presented to Council within the first 60 days and a decision made during the following 30 days. Mr. Gray stated that this would allow for construction to begin by the end of this year. Mathews Southwest has agreed to provide these recommendations, advice and services at no cost to the City. The idea behind this is to end up at the end of 90 days with a specific recommendation on a development agreement regarding the hotel and event center and after the 6 month period, a specific recommendation on a development agreement on the remaining tract. He stated that the letter of agreement states that there is no cost to the City for that period of Mr. Gray stated that this does not guarantee that we will be entering into a Developer agreement with Matthews Southwest, however, it is entering into direct negotiations with the developer that rose to the top during the request for proposals. Council unanimously approved the motion by Council member Harris, seconded by Mayor Pro-Tem Ussery, to approve a Resolution authorizing the City Manager to negotiate a contract with the Matthews Southwest for development services related to the Gateway Project including the Hotel-Events Center and the Office-Retail Area with the attached letter of intent. Caption reads as follows:

11-418 Mayor Loughmiller called for Consideration/Discussion/Action on an Ordinance Calling a City Charter Amendment Election to be Held on November 8, 2011. City Manager Jason Gray stated that the City of McKinney currently has 3 year Council member terms which means that the City holds elections on both even and odd numbered years. S.B. 100 brought the State of Texas into alignment with Federal laws regarding the Military and Oversees Voter Empowerment Act (MOVE)

and has made it more difficult for the City to continue with the May elections on both even and odd years. Originally, the Collin County Elections Administration Office stated that they will not continue to hold May elections in even numbered years. After speaking with other jurisdictions in Collin County and the Commissioners Court, the Election Administrator has agreed to conduct the elections in even numbered years but at a substantially higher cost than we are typically charged. One of the options would be to call a charter election for November 8<sup>th</sup> that would propose to the voters to change the Council member terms from 3 to 4 years. The deadline to call the election would be September 7<sup>th</sup>. He stated that State Law allows for the term of office to be changed by resolution and stated that it does not have to be done by charter, however the Texas Municipal League attorneys' have advised that it is advisable to hold a charter election which takes away any question about whether or not the voters agree with the change. He stated that if Council wishes to stay with the current three year terms, it is very likely that the cost of the May, 2012 would be at a significant increase in cost. Mayor Loughmiller stated that he has spoken to different cities and the City of Plano is calling a charter election for November 8<sup>th</sup> to move from 3 year to 4 year terms. Council requested some additional language be included in the Ordinance. Mayor Loughmiller stated that this item will be readdressed at the end of the meeting to allow the City Attorney an opportunity to craft the new language to be included in the Ordinance.

Mayor Loughmiller called for Consideration/Discussion/Action on a Resolution Authorizing the Purchase of Fifteen (15) 2011 Crown Victoria Police Interceptors for the Police Department. City Manager Jason Gray stated this came up during the budget discussions. The stoppage of fleet replacement program for the police department during the current FY2011 budget year has placed us in a position that will be difficult to catch up. The funding of \$350,000 for the additional police vehicles

would come through savings from the current FY2011 budget. Mr. Gray stated that he is requesting approval of the \$350,000 to purchase as many vehicles as that amount would allow. The funding would come through current year savings and will maintain the existing level of budgeted dollars within the general fund. Mr. Gray stated that this will get the City back on track with the police fleet replacement program. Council unanimously approved the motion by Council member Day, seconded by Mayor Pro-Tem Ussery, to approve a Resolution authorizing the purchase of fifteen (15) 2011 Crown Victoria Police Interceptors for the Police Department. Caption reads as follows:

11-421 Mayor Loughmiller called for a Public Hearing for Consideration/Discussion/Action on a Resolution Adopting a Redistricting Plan to be Submitted to the Department of Justice. Mayor Loughmiller stated that there are three maps that have been posted on the City's website: (1) Plan 1 which was the City Council's map that was created prior to the August 8<sup>th</sup> public hearing, (2) Plan H which was created with the demographers in response to the comments received at the August

8<sup>th</sup> public hearing, and (3) Citizen Proposal 1.

Mayor Loughmiller called for public comment.

Mr. Joe Steinbauer, 2312 Trenton, McKinney, spoke in opposition of the Citizen Proposal Map.

Mr. Neal Ator, 512 W. Virginia, McKinney, spoke in favor of the City's proposed Redistricting Plan H. Council unanimously approved the motion by Mayor Pro-Tem Ussery, seconded by Council member Ricchi, to close the public hearing and approve a Resolution adopting a Redistricting Plan H to be submitted to the Department of Justice. Caption reads as follows:

11-422 Mayor Loughmiller called for а Public Hearing for Consideration/Discussion/Action on the Budget Appropriation Ordinance for FY 2011-12 - 1st Reading. City Manager Jason Gray presented an update to the proposed budget. Mr. Gray stated that this is a balanced budget with \$1.5 million increase in revenues from the current fiscal year. Mr. Gray is recommending that the tax remain the same for FY2011-12 and that the vacation buyback program be extended for one additional year. Mr. Gray stated that the civilian employees would be given raises of 2% with a minimum of \$1,000 and a maximum of \$2,000 added to their base pay. Mr. Gray is also proposing to give the public safety personnel a one step increase on October 1st and another step increase on their anniversary date. Mayor Loughmiller called for public comment and there were none. Council unanimously approved the motion by Council member Harris, seconded by Council member Kever, to close the public hearing and approve the first reading of the Budget Appropriation Ordinance for FY 2011-12.

11-423 Mayor Loughmiller called for Public Hearing for Consideration/Discussion/Action on Application #11-06 as Submitted by City of McKinney Public Works Department Requesting up to \$260,000 for Building Improvement to McKinney Performing Arts Center. McKinney Community Development Director Cindy Schneible presented the request from the City of McKinney for funding building improvements for the McKinney Performing Arts Center. Ms. Schneible stated that these repairs were approved unanimously by McKinney Community Development Corporation at their July 26th meeting in an amount not exceeding \$250,000. Council members expressed concerns with some of the cost estimates for items included in the request. Executive Director of Public Works Hal Cranor stated that most of the items requested are maintenance items. Mr. Cranor stated that it costs \$75,000 to maintain this building each year. Mayor Loughmiller called for public comment and there were none.

Motion by Council member Day, seconded by Council member Kever, to deny this item failed due to a lack of a majority with a vote of 3-3-0, Council members Kever, Day, and Ricchi voting for and Mayor Loughmiller, Mayor Pro-Tem Ussery, and Council members Harris, voting against.

Motion by Council member Harris, seconded by Mayor Pro-Tem Ussery, to approve this item failed due to a lack of a majority with a vote of 3-3-0, Mayor Loughmiller, Mayor Pro-Tem Ussery, and Council member Harris voting for and Council members Kever, Day, and Ricchi, voting against.

Mayor Loughmiller called for Consider/Discuss/Act on an OrdinanceCalling a City Charter Amendment Election to be Held on November 8,2011

Council unanimously approved the motion by Council member Ricchi, seconded by Council member Kever, to approve an Ordinance Calling a City Charter Amendment Election to be Held on November 8, 2011 with the following changes: to Proposition 3: "Each person duly elected to the position of Mayor or Council Member shall perform the duties and discharge the obligations conferred and imposed upon them, respectively, by the law, this Charter and by the City Ordinances of McKinney and shall hold their office for a period of four (4) years and until their successors are elected and qualified. Beginning with the 2013 election, and every election thereafter, the Mayor shall be allowed to hold his/her seat for a limit of two (2) consecutive, full four-year terms, and including two terms consisting of a current three year and a four year term. Beginning with the 2013 election, and every election thereafter, each person duly elected to the position of Council Member shall be allowed to hold any at-large seat, including consecutive terms in two separate at-large seats, for a limit of two (2) consecutive, full fouryear terms, and including two terms consisting of a current three year and a four year term. Beginning with the 2013 election, and every election thereafter, each person duly elected to the position of Council Member shall be allowed to hold any district seat, including consecutive terms in two separate district seats, for a limit of two (2) consecutive, full four-year terms, and including two full terms consisting of a current three year and a four year term. After serving two consecutive terms in an atlarge or district seat(s), an at-large member shall not be eligible to serve in a district or at-large seat until the passage of one year from the end of such two consecutive terms; however such member may serve as Mayor. After serving two consecutive terms in an at-large or a district seat(s), a district member shall not be eligible to serve in an at-large or district seat, until the passage of one year from the end of such two consecutive terms; however such member may serve as Mayor." Mayor Loughmiller called for Council and Manager Comments

Council member Ricchi expressed his appreciation for the citizen input regarding the skateboard park. Mr. Ricchi reminded everyone to attend the 9/11 remembrance on Sunday, September 11<sup>th</sup>. Mr. Ricchi stated that he appreciated the citizen involvement in the redistricting process.
