Narrative

The McKinney Musical Arts Society sponsored another successful Young Artist Competition on April 12-14, 2013, thanks in large part to the grant we received from the McKinney Arts Commission.

Dr. Spencer Myer, a graduate of The Julliard School and gold medalist of the 2008 New Orleans International Piano Competition, served as our guest artist, judge, and clinician. His arrival early in the week allowed him to conduct masterclasses with two different orchestra classes at Faubion Middle School on Thursday, April 11th as a service to the community. The students were very well prepared, responding eagerly to Dr. Myer's creative suggestions and asking intelligent, thoughtful questions. Each student was given two comp tickets, one for the student and one for a parent, to attend the Friday night concert. Those that attended that concert manned a table where they solicited donations for an upcoming summer orchestra camp.

Dr. Myer's Friday evening concert featuring music of Haydn, Schubert, Albeniz, and Stravinsky at the Heard-Craig performance Hall was spectacular and well attended, with an estimated audience of 125-150. Thirty-four tickets were sold at the door (10 students @ \$5, 22 adults @ \$20, and 2 seniors @ \$17). The majority of the audience held comp tickets—all of the contestants, their parents and teachers, and donors who contribute \$200 or more. All other events were free and open to the public.

On Saturday morning, ten finalists (all high school-age) performed 20-minute programs from memory for the competition. First United Methodist Church, across the street from the hall, graciously allowed us access to their sanctuary piano where the competitors warmed up.

After a lunch break, the students reassembled for a masterclass taught by Dr. Myer. Seven students received 30 minutes of individual instruction while the others listened and observed. The remaining three were taught in a second masterclass on Sunday afternoon.

Following the Sunday masterclass, each finalist played one piece on a final recital. At the conclusion of the recital, the winners of the competition were announced. Four grand prize winners (David Nie and Patrick Pan, both from Sugarland; Emily Tan from Plano; and Sondra Yu from Allen) were given \$1,000 awards. The other students who came from Dallas, College Station, Plano, Houston, and Laredo were awarded \$300 and the chance to return and compete again.

Enrique Rangel's mother wrote a note to Karen Austin, our Artistic Director, expressing her appreciation for the event: "We want to commend you and the McKinney Arts Commission for supporting such a wonderful artistic event for the benefit of our young talented pianists. It was very well organized, and all the events were very well planned. We enjoyed the concert by Dr. Spencer Myer and all the activities during the weekend. We were also overjoyed having met our "cheering" couple and were very impressed with the great support from all your community for our children during this event. The competition was a positive learning experience for our son, and we enjoyed meeting so many friendly and gracious people...It was certainly worth the long trip (they came from Laredo) and sacrifice we had to make to take our son to this competition."

We stayed close to our original budget for this event and were able to solicit donations to cover our costs. These donors were recognized in our program, including the McKinney Arts Commission.

Board member Roy Austin submitted an article to the McKinney Neighbors Go which was printed. We also made the calendar section of that paper as well as the Metro Section of the Dallas Morning News two weeks in a row. We purchased air time on WRR, the classical radio station in the Dallas area, to publicize our event and purchased ad space in the Voice of Change program book, the TMTA and Oklahoma Music Teacher's magazines along with the Dallas Music Teachers' Newsletter. Karen Austin wrote many letters and emails to piano teachers in Texas and Oklahoma, informing them of the competition and encouraging them to send their best students. (This was the second year we included Oklahoma in our publicity. Since we didn't get any applicants either year, we have decided to discontinue our efforts there and focus only on the students in Texas.) Roy also had large signs printed and posted them in front of the hall about a week before the event to advertise.

All of our board members assisted in making the weekend run smoothly, from helping with the programs to working in the kitchen where we supplied water and snacks to the competitors and hosted two post-concert receptions. Photographs were taken to document the events, and we were all present to congratulate and encourage the students.

In addition, local families and individuals volunteered to act as hosts for each contestant, providing both encouragement (aka"cheering") and information as needed during their weekend stays.

The McKinney Young Artist Competition supports our mission statement as well as the goals of the Arts Commission to develop the arts and enrich the cultural environment of McKinney:

The McKinney Musical Arts Society is dedicated to excellence in performance that fosters musical enjoyment, education and awareness. Our primary purpose is to support the McKinney Young Artist Competition for pianists while bringing quality musical performances to McKinney. We are committed to diverse and creative musical productions, supporting the performing arts, and encouraging young artists.
