

Alternate Notice (Sec 211.007d)

211.007(d) The governing body of a home-rule municipality may, by a two-thirds vote, prescribe the type of notice to be given of the time and place of a public hearing held jointly by the governing body and the zoning commission.

Proposed Alternate Notice

- Legal Notice. On or before the 16th day before the date of the public hearing, the city shall cause a notice of the time and place of the public hearing to be published in the newspaper of general circulation in the city;
- Internet Notice. On or before the 30th day before the date of the public hearing, the time and place of the public hearing will be posted on the city's Internet website;
- Internet Posting. On or before the 30th day before the date of the public hearing, a final draft of the proposed Unified Development Code will be posted on the city's website;
- Informational Advertisement. The city shall cause an informational advertisement providing the time and place of the public hearing to be posted in the October edition of the Community Impact Newspaper; and
- Community Announcement. An informational flyer providing the time and place of the public hearing shall be included in City of McKinney Utility Services Statements (utility bills) mailed in the month of October.
