

OWNERS DEDICATION STATE OF TEXAS COUNTY OF COLLIN

SITUATED in the T.T. Bradley Survey, Abstract 88, in the City of McKinney, Collin County, Texas, being part of Lot 3, Block 12 of Waddill Addition as recorded in Volume 78, Page 428 and all of Lot 1, Block A of Winteg Francis Addition as recorded in Volume 2018, Page 230 of the Plat Records of Collin County, Texas, said premises being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod found in the west right—of—way line of Francis Street and marking the southeast corner of Lot 3J of Waddill addition and the most northerly southeast corner of said premises;

THENCE with the north right—of way line of said road and the south line of said premises, South 88°17'25" West, 10.02 feet to a capped iron rod set marking the northeast corner of Lot 1, Block A of Winteg Francis Addition and an interior corner of said premises;

THENCE with the west right—of way line of said road and the east line of said premises, South 01°57′59" West, 59.83 feet to a capped iron rod set marking the southeast corner of said premises;

THENCE departing said road and with the south line of said premises, South 89°17'01" West, 105.07 feet to a capped iron rod set marking the most easterly southwest corner of said premises;

THENCE with the west line of said premises, North 01°55'36" East, 60.00 feet to a capped iron rod set marking an interior corner of said premises;

THENCE with the south line of said premises, South 89°17'01" West, 85.00 feet to a capped iron rod set in the east line of North Waddill Street and marking the southeast corner of said premises;

THENCE with said road and the west line of said premises, North 01°55'35" East 72.38 feet to a capped iron rod found marking the northwest corner of said premises;

THENCE with the north line of said premises, North 89°18'15" East, 200.17 feet to the point of beginning and containing 0.477 acres of land.

1) According to the Flood Insurance Rate Map of Collin County, Texas, Map No. 48085C280J, Map Revised June 2, 2009, there herein described property is located in Zone "X", described by said map to be "areas determined to be outside the 0.2% annual chance floodplain".

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

That, Kenneth J. Olthouse and Darrell L. Tate and Gayle L. Tate are the owners of the above described property and do hereby adopt this Minor Replat designating the hereinabove described property as WINTEG FRANCES WADDILL ADDITION LOT 1R AND LOT 2, BLOCK A, being a replat of part of Lot 3, Block 12 of WADDILL ADDITION and all of Lot 1, Block A of WINTEG FRANCES ADDITION as recorded in Volume 78, Page 428 and Volume 2018, Page 320 respectively of the Deed Records of Collin County, Texas and do hereby dedicate to the public use forever, the streets, alleys and public use areas shown hereon; the easements, as shown, for the mutual use and accommodation of the City of Mckinney shall have the right to remove and keep removed all or parts of any building, fences, shrubs, trees or other improvements or growths which in any way, endanger or interfere with the construction, maintenance or efficiency of it's respective systems on said easements; and the City of Mckinney and all public utilities shall have the right to construct, reconstruct, inspect, patrol, maintain and add to or remove all or parts of it's respective systems without the necessity of, at anytime, procuring the permission of anyone. This plat approved subject to all platting ordinances, rules, regulations and resolutions of the City of Mckinney.


