



Dear Planning and Zoning Board Members:

I am not able to make your meeting this week, but I want to express my view concerning the potential rezoning of the land on Grey Branch Road in McKinney (case # 15-099Z) for development. I would ask that you vote NO to the rezoning request! I don't live on that road, but my family and I have been walking up and down that road since 1999 enjoying its beauty and tranquility. Grey Branch road is like a little oasis in the middle of our growing city. Our city is growing by leaps and bounds, but I believe that it is incumbent on us to save places that are as pristine as Grey Branch Road for our future generations.
