**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING THE FOLLOWING FUNDING ALLOCATIONS FOR THE SUPPORT OF THE ARTS IN MCKINNEY IN THE AMOUNT NOT TO EXCEED \$350,000; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Arts Commission for the City of McKinney received grant applications from various groups totaling \$350,000

**WHEREAS**, the 2024-2025 budget for the City of McKinney includes \$350,000 for the support of the Arts and arts groups operating in the City of McKinney; and

**WHEREAS**, the City Council of the City of McKinney, Texas, finds and determines the following funding accomplishes a public purpose and municipal purpose for the City of McKinney.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT**
