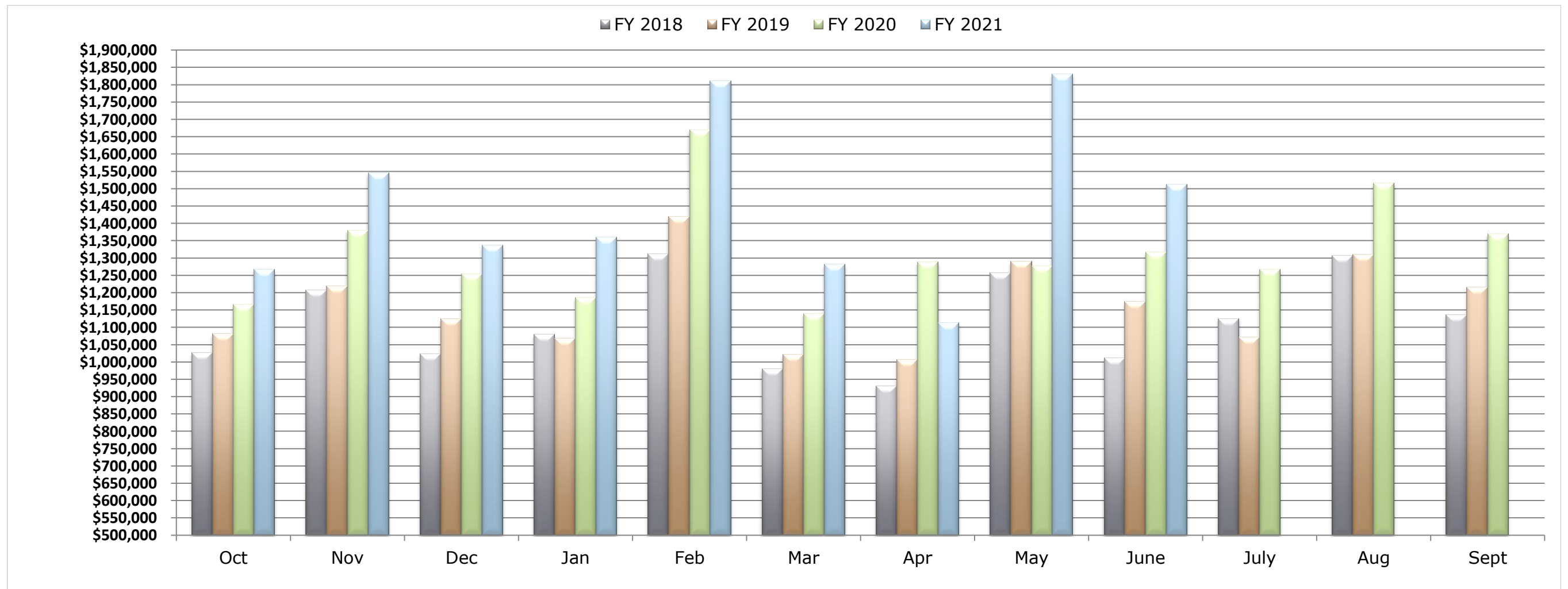

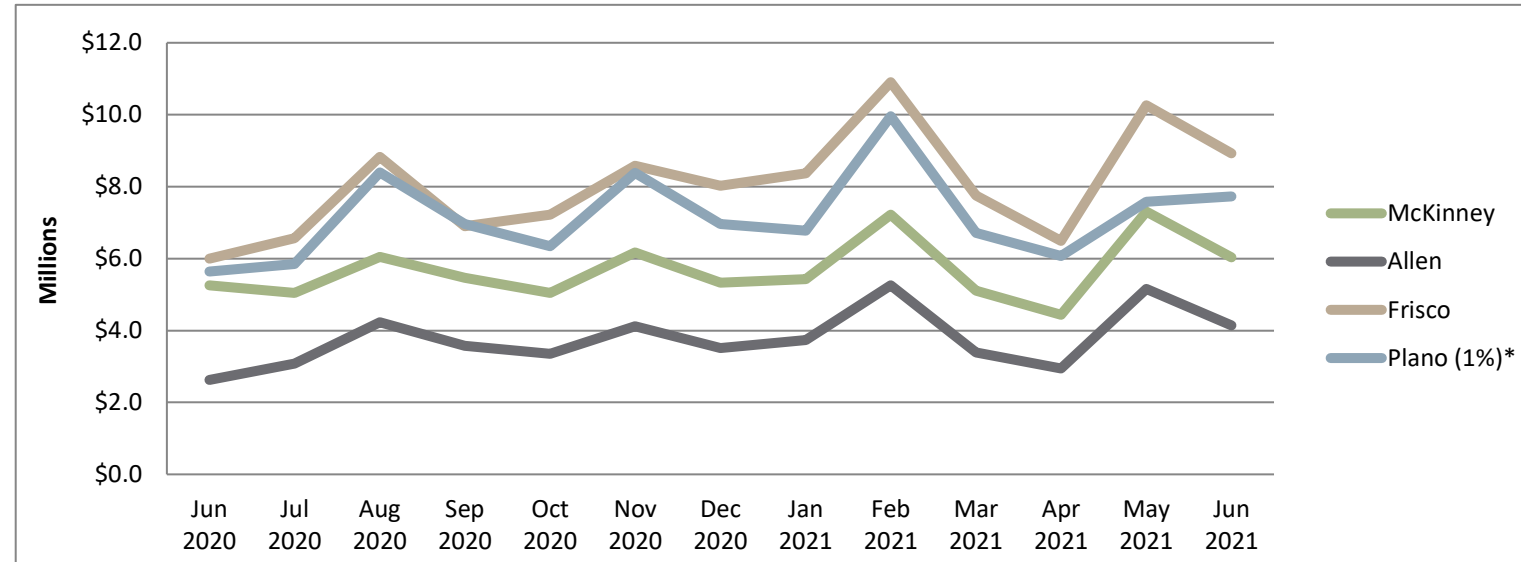


TOTAL SALES TAX COLLECTED
