Dear Planning and Zoning Commission Members,

Approximately 9 months ago (June, 2020) we became aware of engineers doing survey work near our property line which is located at 10105 Sailboard Drive, McKinney, TX. Our property, lot 59, is near the northeast corner of Furr Elementary School, Prosper ISD. Upon further inquiry we became aware that Prosper ISD was in the process of negotiating with a telecommunications company to consider application for rezoning to allow for the installation of a 5G cell tower on school property. We began addressing concerns with the school district, the telecommunication planners and with the Director of the city's planning and zoning commission. Our concerns included:

- Environmental impact of RF emissions from a 5G cell tower in close range to residential homeowners
- Environmental impact of RF emissions from a 5G cell tower in close range to young children on school property
- Physical safety of a multi story cell tower in close range to residential homes & children playing outdoors
- Aesthetic impact of multi story cell tower installation near residential property

From a regulatory perspective, our concerns **do not** discriminate between providers as our complaint is all inclusive. Our concerns **do not** ask to prohibit the provision of wireless service. Indeed, wireless service is readily available in our area. And, we certainly **do not** ask to prohibit the provision of 5G cell towers on other tracts of land, further away from school and residential properties. Regardless of federal law which may preempt local decisions based on RF emissions, we have read research and, from what we read, there is no conclusive, concrete, long term definitive evidence regarding the safety of RF emissions from 5G cell towers, as the development of 5G cell towers is still in its infancy.

From an aesthetic perspective as homeowners, we would be forced to constantly view this cell tower from our backyard. Although we support the existence of our neighborhood school, the school property elevation and traffic flow have significantly impacted our privacy and the privacy of other homeowners. Due to the higher elevation of the school we are able to view all northside outdoor activity from our backyard. Fencing and shrubbery have NOT created a privacy barrier between the school and residential properties along the north side. **A cell tower just adds one more layer to the impact the school has had on nearby property owners. Significant traffic occurs on the north side of the school where the cell tower installation is proposed. This is what we experience because the school elevation and traffic is so high:**

- Carpool lines, twice a day, outdoor PA system blaring announcements as parents/students come and go
- Semi trucks delivering supplies to the north side entrance, several times weekly
- Student bikers using the north side to arrive, park and leave school grounds
- Outdoor Phy Ed area with painted game parameters, tether ball apparatus & use of green space for team sports
- Garbage disposal and removal site used by large sanitation trucks, twice weekly
- Gated playground used by lower primary grades and child care, 4 or more times daily
- Delivery and pick up site for summer food program
- Parking stalls, used daily by school staff, carlights shining in windows, when dark

Finally, we are not aware that the school district has made any outreach to inform parents that a proposal for a cell tower is moving forward! As we have a grandchild that attends the school, we know that parents have not been given an opportunity to voice concerns or comments. There seems to be a lack of transparency. **Please have the district notify school parents!**

In conclusion, if the power and regulatory authorities preclude concerns from any community citizenry, and decisions support the approval of this proposal, we would respectfully request any of the following to be considered:

- Consider cell tower placement on another section of the property, perhaps along the south east end of the school where there is less traffic and a cell tower may not be in direct view of adjacent property owners
- Consider provision of a matching masonry barricade NOT LESS THAN HALF THE HEIGHT OF THE TOWER, making the cell tower less visible to traffic and nearby property owners, as well as adding more protection. For an 85 foot tower, including antennae, that would mean a masonry barricade greater than 44 feet.
- Consider the lightening rod as part of the overall height when assessing the distance from home properties.
- Consider working with local Homeowners Association to evaluate and build higher fence barrier between school and residential properties on the north side so school. Currently 5-6 homes along the north driveway have full and unobstructed view of the school driveway, parking stalls and school structure on the north & east.
- Consider working with landscape planners to add more **deciduous trees** to the property that would provide year round privacy barrier along the north side of the school driveway.
