The regular meeting of the Housing Authority of the City of McKinney was held on October 22nd at 2:00pm.

Commissioner Beller gave the invocation.

The next item of business was the administration of the Oath of Office. City Secretary Sandy Hart conducted the official business of swearing in and oath of office for all Commissioners.

The board then proceeded to the election of officers. Justin Beller was elected Chairman. Julie Smith was elected as Vice Chairman.

The Chairman called for comments from the public. Resident Nicki Leeks inquired as to when the Merritt Homes property would be rebuilt.

The next item to consider, old business. Consider/Discuss/Act on Amendment to Public Housing & Section 8 Wait List (09.01.13.06) – Commissioner Smith motioned to approve the recommendation of

staff to amend the wait list preferences at the next opening. Commissioner Hammer seconded the motion. A vote was taken with the following results.

The Chairman called for the next item to consider/discuss/act on the Resident Council Update. Ms. Miller advised of the September meeting in which the Newsome residents toured the Sheppard's Cove Property in Dallas. The adults stuffed 400 goodie bags for participants and the children along with Team dV8 made thank you cards. No action was required.

Item nine called for an update of the Millennium McKinney Project. Representatives from Sanchez and Associates provide an overview of the project since receiving the tax credit award. In addition, they discussed challenges to the project with regard to Impact Fees.

Will Henderson with Carleton provide an update of the Newsome Homes project? Mr. Henderson expressed concern regarding challenges getting through the planning and zoning with the City. The staff and developer requested an approval of the board for the final project design and unit conversion (10.22.13.02) Commissioner Beller motioned to approve the final project design. Commissioner Smith second. Commissioner DeCoste motioned to approve the unit conversion. Commissioner Beller second. A vote was taken with the following results.

The next item on the agenda was to consider/discuss/act on Green Homes. Humberto Rodriquez with Advance Casas gave a presentation regarding building energy efficient single family homes. No additional action was required or taken.

The Chairman called for the next item to consider/discuss/act on the Financials. A motion was made by Commissioner Beller to approve the items as presented along with the write-offs. Commissioner Smith seconded the motion. A vote was taken with the following results.
