Chair Report – Board Chair Harbor advised board members that the Sheraton Hotel has offered to host a tour of their facility on Friday, February 6, 2015 at 10:00 a.m.

Director's Report - Executive Director Guerra asked board members to refer to the staff report she had provided for them. Guerra highlighted the following activities that she and staff members accomplished during the month of December 2014:

- Ms. Guerra attended two trade shows during the month of December and met with 17 meeting planners at the Reverse Latin Trade Show.
- Staff processed 1670 leads from individuals asking for visitor information on McKinney, submitted 6 new wedding RFP's and one sports RFP.
- Ms. Guerra reviewed the analytics and ROI from marketing efforts including VisitMcKinney.com, our social media accounts, and two recent digital campaigns with TTIA and Tripinfo.com.
- February 26, 2015 is the grand opening of the Sheraton Hotel & Conference Center; they will offer a special room rate of \$69 for that weekend.
- Board Chair Harbor asked on the status of PSA-McKinney, Executive Director Guerra advised board members the facility is open and staff is working closely with PSA-McKinney to assist in securing hotel rooms for teams hosted by PSA-McKinney for national tournaments.
- Ms. Guerra thanked board members for volunteering to assist at the Toyota open house events taking place in February.

Finance Committee Report – Board member Alfieri reported the finance committee met on January 13 to review the financials from November and stated the MCVB financials were tracking as projected.

Development/Marketing Report – Board member Estes spoke on behalf of Committee Chair Huggins advising board members that the Marketing Committee met on December 5, 2014. Ms. Estes stated the committee reviewed the advertising/promotions expenditures over the last month. In

visitors. In addition, search engine optimization was also a topic of

discussion, as well as reviewing opportunities with YELP and Facebook.

HR Committee Report - Committee Chair Alfieri advised the committee

met to create a working plan. She stated she emailed Interim City

Manager Tom Muhlenbeck asking for a copy of an evaluation he had

helped to produce for other departments and is awaiting the receipt of

that evaluation.

City of McKinney - Finance Budget Manager Mark Holloway stated the

finance department was working closely with McKinney City Council and

City Management on a long term financial plan and a possible bond

election coming up in May or November 2015.

Main Street/MPAC - Executive Director Rosenthal advised board

members that MPAC had a very successful bridal show with over 600 in

attendance. In addition, Rosenthal advised board members of upcoming

events that will take place in historic downtown McKinney and at MPAC.

MCDC Report - MCDC board liaison David Myers stated MCDC is

currently accepting their first round of grant applications through January

30, 2015. Mr. Myers advised board members that the MCDC quality of

life award recipient will be announced at the Chamber award dinner. In

addition, Myers advised that the CDC board continues to monitor the

progress of the Aquatics center.
