**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING THE FOLLOWING FUNDING ALLOCATIONS FOR THE SUPPORT OF THE ARTS IN MCKINNEY IN THE AMOUNT NOT TO EXCEED \$200,000; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS,** the Arts Commission for the City of McKinney received grant applications from various groups totaling \$200,612

**WHEREAS,** the 2021-2022 budget for the City of McKinney includes \$200,000 for the support of the Arts and arts groups operating in the City of McKinney; and

**WHEREAS,** the City Council of the City of McKinney, Texas, finds and determines the following funding accomplishes a public purpose and municipal purpose for the City of McKinney.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT**
