

**ORDINANCE NO. 2015-03-\_\_\_\_**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF  
McKINNEY, TEXAS AUTHORIZING A CERTAIN BUDGET  
AMENDMENT PERTAINING TO THE FISCAL YEAR 2014-2015  
BUDGET AND THE 2015-2019 CAPITAL IMPROVEMENTS PROGRAM;  
AND PROVIDING FOR AN EFFECTIVE DATE HEREOF**

**WHEREAS**, as required by the City Charter, the Interim City Manager has prepared an amendment to certain appropriations and expenditures/expenses in the 2014-2015 Budget and the 2015-2019 Capital Improvements Program and submitted same to the City Council for its approval and a true and correct copy is attached.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF  
McKINNEY, TEXAS, THAT:**

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, in the Fiscal Year 2014-2015 Budget Amendment as attached is hereby authorized and approved.
- Section 2. The budget shall be amended by transferring \$285,411 from Parkland/Median Fee Fund (Median Escrow Zone G \$79,562, Zone I \$130,119, Zone J \$47,098, and Zone K \$28,632) to the Park Construction Fund and to set up a new CIP project PK4389 Ridge Road, Hardin Boulevard, and Airport Road Median Improvements.
- Section 3. The budget for the Ridge Road, Hardin Boulevard, and Airport Road Median Improvements (PK4389) shall be amended by appropriating \$285,411 in the Park Construction Fund.
- Section 4. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, and it is accordingly so ordained.
