#### **TUPPS Brewery Expansion**

The TUPPS team presented an update on the status of the TUPPS expansion project to the MCDC board at a special meeting that took place on February 1<sup>st</sup>. A subcommittee of the board was appointed to work with the team and review design for the site as it evolves. A meeting of the subcommittee took place on February 10<sup>th</sup>. Bi-weekly progress meetings continue. Work on design and refinement of the project budget continue. A site plan was submitted to the City on February 8<sup>th</sup>. An SUP will be required because of the outdoor/entertainment components of the plan as part of the process.

# **Retail Development Infrastructure Grants**

Two Retail Development Infrastructure Grant applications have been received for board consideration:

- Haddington Fund, LP James Bresnahan for site improvments needed for Ashlee's Garden at the Mill at East McKinney.
- Improvements to surface drainage and rear alley surface in the area behind the east side of Tennessee between Louisiana Street and Cloyd Street; west side of the Dowell Building at 208 E. Louisiana; and the Dowell Tin Shop at 208 Johnson Street.
