If we want to bring retail to our area, PLEASE consider reviewing communities such as **Castle Hills, located off Hwy 121** and Josey/Main Street. It is a stunning community with retailers that actually add value, not cheapen it. This area is considered Lewisville.

The homeowners in Robinson Ridge and those still building have paid a hefty price to live in this community and quite honestly if we wanted to live in cheap areas, we would have moved east of I75. Eleana,

Thank you for the prompt response and offing to keep me in the loop. I can tell you that I am a house that is outside the 200 feet zone, but whose fence backs up to the vacant lot. I would be the house next to the number 668 on the map you sent me.

A 7-11 is a 24 hour, 7 days a week operation, with delivers and pickups at all hours of the night. This will be a nuisance to the neighborhood! I have invested a lot of money into fixing up my house, and was hoping that this home would be where I finally settle down and retire at. I realize that the property was zoned for retail, and we all welcome retail. Most retail are closed at night, service their community and add value to the surrounding neighborhood.

Convenience stores like 7-11 account for 6% of crime nationwide. Now that might not seem like a lot, however, this 6% had remained unchanged over the last 30 years. They are repeatedly victimized by location. This is inviting crime to our neighborhood who has already seen an uptick in crime without this store. I live in a darken street with only one street light offering little deterrent to crime, we have no police presence to help keep the area safe and I seem to be the one of a few homeowners leading the charge to put in outside landscaping lights to brighten up the area. I don't feel that we need anything like a 7-11 to just invite more crime to our area.

Furthermore, we need to look at the environmental issues caused by gas stations and the reason we don't see many so close to homes. I think that the City of McKinney owes it to the homeowners to do the right thing. Build retail, build shops, put in a whatever is needed to help beautify the area, but not a 12 station, gas service company like 7-11.

I have given your name to all the neighbors in my community. I will be going door to door soon if I need to in order to block this proposal. You are telling me that they are trying to work out "fire issues", which is something that you can't control 100% when you are dealing with a flammable product on a 24/7 basis. Not to mention everything else that I stated above.

In closing, this is in your hands. I pay taxes, I adhere to all the rules and laws of the City of McKinney. This is a great place to live, and you all preach about keeping things green and respecting the land. Let's not sell out to a corporation like 7-11. They already have two on Lake Forest and they don't need a third location here!

Please keep me informed and I do hope you begin to hear from more of my neighbors as I have been very vocal on our community blogs.
